In exercise of the powers conferred by Section 228 and sub-section (1) of Section 242 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994), and in supersession of the Rules relating to composition of offences, the Governor of Tamil Nadu hereby makes the following Rules:-

## **RULES**

- **1. Short title.-** These Rules may be called the Tamil Nadu Panchayats (Composition of Offences) Rules, 2000.
- 2. The offences punishable under the Sections of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994) specified in column (1) of the Table below shall be declared as compoundable by the Executive Authority or the Commissioner or the Secretary, as the case may be, for the amount specified in the corresponding entries in column (2) and with the permission of the Court before which any prosecution for such offence is pending, wherever such permission is necessary as specified in the corresponding entries in column (3) thereof.
