ORDER:

In the Government Order thirteenth read above, sanction was accorded for further continuance of the 54 temporary posts to Tamil Nadu State Election Commission from 1.7.2008 to 30.6.2009.

2. In the letter fourteenth read above, the Secretary, Tamil Nadu State Election Commission has requested the Government to sanction the continuance for 54 posts for a further period of one year from 1.7.2009 to 30.6.2010 as the Tamil Nadu State Election Commission is conducting indirect elections in rural and urban local bodies every month and casual elections once in 6 months periodically. After the completion of every election the Tamil Nadu State Election Commission is continuously engaged in carrying out the post election works like:-

- (i) Compiling of election results.
- (ii) Publication of election results in Government Gazette.
- (iii) Obtaining and scrutinizing the reports on election expenses accounts lodged by the elected representatives and disqualifying the defaulters who have failed to lodge the accounts within the stipulated time.
- (iv) Taking follow up actions in the E.O. Petitions filed in various District Courts throughout the State.

The Commission has decided to take up the following important election related works also:-

- 1. Preparation of election manuals.
- 2. Suggesting amendments to Acts and Rules
- 3. Incorporation of uniform provisions in Panchayat and Municipal Acts/Rules.
- 4. Simplification of election procedures.
- 5. Preparation of compendium of instructions issued by the Tamil Nadu State Election Commission.
- 6. Improving the election hand book.
- 7. Preparation of Tamil Nadu State Election Commission administration manual.

3. The Government have examined the proposal of the Tamil Nadu State Election Commission for continuance of the staff and decided to accept it. Accordingly the Government accord sanction for the continuance of fifty four posts referred to in the Annexure to this order, to the Tamil Nadu State Election Commission for a further period of one year from 1.7.2009 to 30.6.2010.

4. The posts mentioned in para 3 above are eligible to draw Pay, Dearness Pay, Dearness Allowance, House Rent Allowance, City Compensatory Allowance and other allowances as admissible under the orders in force.

5. The expenditure shall be debited to the following head of account:-

"2070-00-Other Administrative Services – 001. Direction and Administration – I. Non-Plan – AB. State Election Commission – 01. Salaries". (DPC No.2070-00-001-AB-0106)
