### ORDER:

In the Government Order first read above, Government had issued orders for the release of ` .183981.36 lakhs being the devolution grant to the Rural Local Bodies i.e. Village Panchayats, Panchayat Unions and District Panchayats and authorized the Commissioner of Rural Development and Panchayat Raj to draw and disburse the amount sanctioned on monthly basis i.e. from April 2010 to January 2011 to the Rural Local Bodies as indicated therein. Accordingly, the Commissioner of Rural Development and Panchayat Raj has released the funds.

2. The Commissioner of Rural Development and Panchayat Raj in the letter second read above has stated that the Government have allocated a sum of ` .233421.40 lakhs as State Finance Commission (SFC) grant in the Budget Estimate for 2010-2011 as detailed below:

The Government have carefully examined the proposal of Commissioner of Rural Development and Panchayat Raj and decided to accept the proposal and accordingly sanction the release of ` .49440.04 lakhs (Rupees Four hundred and ninety four crores forty lakhs and four thousands only) as the State Finance Commission population based grant to Village Panchayats, Panchayat Unions and District Panchayats for the months of February 2011 and March 2011 and the same shall be distributed among the Rural Local Bodies as detailed below:
