## ORDER:

The Commissioner of Rural Development and Panchayat Raj has stated that a sum of Rs.94,28,000/- has been provided as Maternity Grant and a sum of Rs.29,000/- has been provided as Allopathy Grant in the Demand No.42 of 2009-10 in the following head of Accounts:-

2210-Medical and Public Health – 03 - Rural Health Service – Allopathy – 110 – Hospitals and Dispensaries I Non Plan – Al Grants for Dispensaries of Panchayat Union -09 Grants – in – Aid – 01 Grants for Current Expenditure.

2210 – Medical and Public Health – 03 Rural Health Service – Allopathy – 110 – Hospitals and Dispensaries I Non Plan – BR-Maintenance Grant for Maternity Centres of Local Bodies – 09 Grants – in – Aid -01 Grants for Current Expenditure.

The Government after due consideration accept the proposal of the Commissioner of Rural Development and Panchayat Raj and accordingly sanction a sum of Rs.94,28,000/- (Rupees Ninety four lakhs and twenty eight thousand only) towards Maternity Grant and Rs.29,000/- (Rupees Twenty nine thousand only) towards Allopathy Grant for the year 2009-2010.
