### 12.7 Creation of data base in the PRIs and sanction of Purchase of 6,096 computers accessories

#### ORDER

In the G.O. first read above, sanction was accorded for a sum of Rs.1037.32 lakhs for the purchase of Computers to Village Panchayats / Panchayat Union etc. It has also been ordered therein that out of this amount of sum of Rs.829.75 lakhs shall be met from Eleventh Finance Commission grant and the balance of Rs.207.57 lakhs shall be borne by the Village Panchayats/ Panchayat Unions from their own Funds as 25% matching contribution. In the G.O. second read above orders were issued sanctioning, a sum of Rs.129,60188 lakhs for the purchase of computers to Village Panchayats etc. Out of this amount a sum of Rs.103.68150 lakhs shall be met from the Eleventh Finance Commission grant towards the purchase of computers and the balance of Rs.25.92038 Lakhs shall be borne by the Village Panchayats from their own funds as matching contribution. In the G.O. third read above, orders were issued sanctioning a sum of Rs.3374.59312 lakhs for purchase of computers to Village Panchayats. Out of this amount a sum of Rs.2699.67450 lakhs shall be met from the Eleventh Finance Commission Grant towards purchase of Computers and the balance of Rs.674.91862 lakhs shall be borne by the Village Panchayats as 25% matching contribution.

2. In the letter forth read above the Director of Rural Development has sent a proposal for sanction of sum of Rs.3162.67 lakhs for the purchase of 6086 Computers for supply to the remaining 6086 Village Panchayats under 12<sup>th</sup> Finance Commission Grants.

3. The Government examined the proposal of the Director of Rural Development Carefully and decided to sanction a sum of Rs.24.39 Crores for 6096 balance Village Panchayats at the rate of unit cost of Rs.40,000 per Village Panchayat towards purchase of computers and accessories with UPS and printer. Accordingly sanction is accorded for a sum of Rs.24.39 Crores for 6096 Village Panchayats at the rate of Unit Cost of Rs.40,000 per Village Panchayat towards purchase of P.C and accessories with UPS and printer by utilizing the Local Body grant recommended by the Twelfth Finance Commission. The procurement shall be effected through ELCOT by following the procurement procedures.

4. The Director of Rural Development is authorised to draw and disburse the amount of Rs.24.39 Crores (Rupees Twenty four crores and thirty nine lakhs) sanctioned in para 3 above to the Managing Director, ELCOT.

5. The Expenditure sanctioned in para 3 above shall be debited to the following head of Account:

"3604-00 Compensation and Assignment to Local Bodies and Panchayat Raj Institutions - 197 assistance to Block Panchayats / Inter media level Panchayats JD. Grants to Village Panchayats as per the recommendation of the 12<sup>th</sup> Finance Commission 09 Grants-in-aid 03-Grant for current Expenditure" (DPC No.3604-00-197 JD 0915)

6. Necessary Funds has been provided in the FMA/FSE 2005-06.

7. The Director of Rural Development is requested to send the Utilisation Certificate for the amount sanctioned in para 3 above so as to forward the same to the Government of India.
