ORDER

In the Government Order first read above administrative sanction was accorded for a sum of Rs.100 Crores (Rupees one Hundred Crores only) for strengthening of Bus Plying and non-bus plying Panchayat and Panchayat union Roads to facilitate smooth transportation rural areas under the Comprehensive Road Infrastructure Development Programme for the year 2005-2006.

- 2. In the reference second read above, the Director of Rural Development was authorised to draw the above said amount of Rs.100 Crores and to disburse the same to the District Collectors for the implementation of Comprehensive Road Infrastructure Development.
- 3. Out of the sanctioned amount of Rs.100 Crores, a sum of Rs.75 Crores was provided in the supplementary Estimate for 2005-2006 under Demand No.40(item No.27) and the same has been drawn and distributed to all Districts. He has further added that the balance amount of Rs.25 Crores has been made in the Budget Estimate for 2006-2007 under the Head of account 4515.00-800-JK-1602. He has therefore requested the Government to release the balance of Rs.25 Crores for strengthening of Bus plying non Bus plying Panchayat and Panchayat union road under comprehensive Road Infrastructure Development Programme by giving exemption to the Comprehensive Road Infrastructure Development Programme from quarterly control of appropriation of funds for the current year.
- 4. The Government after careful examination accept the proposal of Director of Rural Development & Panchayat Raj at para 3above and accordingly sanction a sum of Rs.12.50 Crores (Rupees Twelve Crore and fifty Lakhs only) and the balance Rs.12.50 Crores will be released after full appropriation Act is passed by the legislature for Budget Estimate 2006-2007.
- 5. The Director of Rural Development and Panchayat Raj is authorized to draw the amount sanctioned in para 4 above and distribute it to the District Collectors for implementation of the Comprehensive Road Infrastructure Development Programme.
- 6. The expenditure sanctioned in para 4 above shall be debited to the following New sub head of accounts.

"4515.00 - Capital outlay on other Rural Development programme - 800 other Expenditure - Scheme in the Tenth Five Year Plan -11-State Plan -JK Comprehensive Road Development Programmes -Rural Panchayat - and Panchayat Union Roads. 16 Major works (DPC 4515-00-800-JK-1602)

- 7. The Director of Rural Development & Panchayat Raj should ensure the quality of work as per the standards by issuing detailed instruction to the concerned authorities. He is further instructed to closely monitor so that strong quality control steps should be taken and quality work should be done. He is also directed to ensure that the above works have not been included/under taken in another schemes before calling for tender.
