#### **APPENDIX**

#### **NOTIFICATION**

In exercise of the powers conferred by sections 115, 117, 136 and clauses (X Liii ) of sub - Section (2) of Section 178 of the Tamil Nadu Panchayats Act, 1958 (Tamil Nadu Act XXXV of 1958), the Governor of Tamil Nadu hereby makes the following Rules.

#### **RULES**

- **1. Short title and commencement** (1) This Rules may be called the Tamil Nadu Panchayats (Apportionment of the proceeds of Local Cess among Village and Town Panchayats ) Rules, 1992
  - (2) They shall come into force on the Ist day of July 1992.
- **2. Definitions** In these Rules, unless there is anything Repugnant in subject or context.
  - 1) 'Act' means the Tamil Nadu Panchayats Act, 1958 (Tamil Nadu Act XXXV of 1958):
  - 2) 'Panchayat' means the body constituted for the local administration of a Village or town under the Act;
  - 3) 'Panchayat Development block' means the area declared by Government from time to time to be a Panchayat development block for the purposes of the Act;
  - 4) 'Panchayat town' means any local area over which a Panchayat which is classified as a town Panchayat under the Act has jurisdiction;
  - 5) 'Panchayat Village' means any local area over which a Village Panchayat has jurisdiction;
  - 6) 'Local cess' means the amount levied and collected in every Panchayat development block under section 115 of the Act;
  - 7) 'Town Panchayat Fund' means the fund constituted for each Town Panchayat under section 134 of the Act and also includes the fund constituted in each Townships constituted under section 4 of this Act, to which section 134 thereof is extended.
  - 8) 'Village Panchayat fund' means the fund constitued for each Village Panchayat under section 134 of this Act.
- **3. Apportionment of Local cess** Out of the proceeds of local cess collected in every Panchayat development block, a sum representing seventy five percent of the said proceeds shall be apportioned among the town Panchayats and Village Panchayats comprised in the said Panchayat development block in accordnace with these Rules and credited to the respective Town Panchayat

## 13. ASSIGNED REVENUES

Fund or Village Panchayat Fund, as the case may be.

## 4. Apportionment of local cess among town Panchayat -

A sum representing seventy five percent of the amount of local cess collected in every Panchayat town shall be apportioned among the town Panchayat in proportion to the rate of land revenue of the Panchayat town and credited to the respective town Panchayat Fund.

# 5. Apportionment of local cess among Village Panchayats -

sum representing seventy five percent of the amount of local cess collected in every Panchayat Village in the Panchayat Government block shall be apportioned among the Village Panchayats in proportion to the rate of land revenue of the Panchayat Village and credited to the respective Village Panchayat Funds.
