11.19 Constitution of State Council for rural and urban Local Bodies to discuss Issues common to both urban and rural Local Bodies based on the recommendation of the Second SFC

ORDER

As per the provisions laid down in 73rd and 74th Constitutional amendments, the Second State Finance Commission was constituted in the G.O. first read above, to review the financial position of rural and urban local bodies in Tamil Nadu and to make its recommendations. In the G.O. second read above, the Terms of Reference to the Commission were issued in which the Commission was requested to make its report available by 31.10.2001. The Commission submitted its report to Her Excellency the then Governor of Tamil Nadu on 21.5.2001.

2. As per the decision taken by the High Level Committee formed to examine the recommendation of the Second State Finance Commission, the Finance Department has placed the action taken report on the recommendations of the Second State Finance Commission in respect of Chapter VII, VIII, X, XI, XII (Para 21.6 and 21.7 only) and XIII of the report in the Legislative Assembly on 8.5.2002. As decided by the High Level Committee, Rural Development and Municipal Administration and Water Supply Departments were also requested to prepare action taken report and issue Government Orders in respect of recommendations covered in other Chapters of the report of the Second State Finance Commission.

3. The Second State Finance Commission in paras 3.4, 3.5 and 3.6 of its report has recommended that a State Council may be constituted as follows to discuss general policy issues common both to Urban and Rural Local Bodies.

5. The terms of reference of the Council are as follows -

- I. To review and sort out the delays and discrepancies, if any, arising in the distribution of the net proceeds of taxes, duties, tolls, fees, etc, between the State and Local Bodies (both Rural and Urban) and inter-se distribution among the local bodies as per the recommendations of State Finance Commission.
- II. To discuss issues relating to increase or decrease in the reates of taxation towards, 'Assigned Revenue' which will have bearing on the local bodies, before bring a policy decision by the Government.
- III. To consider changes if any, on the issues relating to the fiscal or any functional to be brought about after the acceptance of the State Finance Commission Recommendations.
- IV. To deliberate upon other issues arising between State Government and the local bodies as may be referred to by the Chairman of the Council.

6. The Council shall meet annually in January / February on the eve of the presentation of the budget in the Assembly.
