ORDER

As per the provisions laid down in 73^{rd} and 74^{th} Constitutional amendments, the Second State Finance Commission was constituted in the G.O. first read above, to review the financial position of rural and urban local bodies in Tamil Nadu and to make its recommendations. In the G.O. second read above, the Terms of Reference to the Commission were issued in which the Commission was requested to make its report available by 31.10.2001. The Commission submitted its report to Her Excellency the Governor on 21.5.2001.

2. The Action Taken Report on the recommendations of the Second State Finance Commission in respect of the Chapter X Payment of Pension among others placed before the Legislative Assembly on 8.5.2002, are examined in detail and the following orders are issued.
