

9.6 Instructions to be followed in the preparation of list of Village Panchayats, Panchayat Union wise at the District Level and publishing it once in five years prior to the conduct of ordinary elections

1. Commissioner of Rural Development letter No.88788/2000/PCA4, Dated : 03.04.2001

ORDER

In the reference read above the Commissioner of Rural Development has stated that the Collector being the Inspector of Panchayats in the Panchayat Administrative set up under the TamilNadu Panchayats Act, 1994 may be requested to prepare the list of Village Panchayats and get it printed in the prescribed format as shown in the Annexure to this order. He has further requested that the list should be prepared Panchayat Union wise for each district and the copies should be printed for use of the Collector, Assistant Director (Panchayats) and other Government Officers and for the sale to the Public and Village Panchayats. He has further requested that the Director of Stationary and Printing may be requested to print a list of Village Panchayats for each district on receipt of instruction from the Collector.

2. The Government after careful consideration accepts the proposal of the Commissioner of Rural Development and direct as follows -

- i) The list of Panchayat in the prescribed format as shown in annexure to this order should be prepared by the Collector and get it printed once in five years. This may be printed prior to the conducting of ordinary election to the Panchayats.
- ii) The list should be prepared Panchayat Union wise for each district.
- iii) Sufficient number of copies as may be determined by the Collector, should be printed for the use of Collector, Assistant Director (Panchayats) other Government Officers and also for sale to the Public including Village Panchayats.

3. The Director of Stationary and Printing is requested to print the list of Village Panchayats for each district on receipt of request from the Collectors. The list should be printed in Tamil for each district separately.

4. This order issues with the concurrence of Information and Tourism Department vide its U.O.No.nil, Dated 14.05.2001 and Finance Department U.O.Note No.1535/FS/P/2001, Dated 16.05.2001.
