## ORDER

Consequent on the transfer of the work connected with the Mines and Minerals from the Revenue Department to the Department of Geology and Mines and the operating of separate receipt head of accounts for crediting the revenues derived from the mines, some difficulties have arisen in the adjustment of quarry receipts and the local cess and local cess surcharge collected thereon to the Panchayat Unions. The quarry receipts adjustable to the Panchayat Unions remain unadjusted for over 10 years.

2. The Commissioner of Rural Development has therefore requested to issue necessary orders for opening a separate debit head to the head of account.

0853 Non ferrous mining and Metallurgical Industries 102. Mineral concession fees – Royalties"

3. The Director of Treasuries and Accounts and the Examiner of Local Fund Accounts have recommended that necessary orders may be issued for opening – separate debit head to the head of account.

0853 Non ferrous mining and Metallurgical Industries 102. Mineral concession fees – Royalties"

4. The Government after careful examination, accept the recommendation of the examiner of local fund Accounts and Directors of Treasuries and Accounts and direct that the refund of quarry lease amount be debited to the following detailed head

Payment to Panchayats and Panchayat Unions under the new sub head:

"AD Deduct refunds to be opened under 0853.00 Non ferrous mining and Metallurgical Industries – 102, Mineral concession fees Royalties (DPC 0853 00 102 AD 0105)

The District Treasury Officers are requested to open the above new sub head of account immediately. The District Collector shall be the Controlling authority for the above sub head.

- 5. The Commissioner of Rural Development is requested to take follow up action for adjustment of quarry lease amount pertaining to Panchayats and Panchayat Unions immediately with effect from the opening of the main head of account in G.O. (Ms) No. 1235 Finance dated 23.10.78. He is also requested to let the contents of this G.O. known to the Commissioner of all Panchayat Unions and the Divisional Development Officers.
- 6. This order issues with the concurrence of the Finance Department vide its U.B. No.23511/BG II/89-1, dated 1.3.89.
