## ORDER:

The Hon'ble Minister for Municipal Administration and Rural Development has announced on the floor of the Tamil Nadu Legislative Assembly on 9.4.2012 that Identity Cards will be issued to the representatives of Rural Local Bodies in the year 2012-13. In Tamil Nadu, 1,19,399 representatives of Panchayat Raj Institutions have been newly elected in the ordinary elections conducted in the month of October 2011. A total of 12,524 Village Panchayat Presidents, 99,333 Village Panchayats Ward members, 385 Panchayat Union Chairpersons, 6,471 Panchayat Union Ward Members, 31 District Panchayat Chairpersons and 655 District Panchayat Ward Members have assumed charges in the respective Panchayat Raj Institutions.

Based on the announcement, the Commissioner of Rural Development and Panchayat Raj has sent proposal to the Government seeking permission to issue instructions to the District Collectors to issue Identity Cards to the Panchayat Raj Institutions Representatives in the reference 3<sup>rd</sup> read above.
