Grants – State Finance Commission Grants – Release of grants to Village Panchayats, Panchayat Unions and Districts Panchayats for April 2011 to January 2012 - Orders issued.

In the Government Order first read above, the Government have ordered to apportion the devolution grant for Rural Local Bodies among the Village Panchayats, Panchayat Unions and District Panchayats in the ratio of 60:32:8 respectively and to reserve 5% from out of 60% of Village Panchayats share of State Finance Commission devolution towards Infrastructure Gap Filling Fund. Out of the above Infrastructure Gap Filling Fund, 50% shall be allocated towards Anaithu Grama Anna Marumalarchi Thittam and out of the balance 50%, of the fund, a part of the amount shall be allocated to the Director of Rural Development for providing basic amenities in the Districts and the rest shall be allocated to the Districts based on population and the District Collectors shall utilize the funds for the same purpose. It is also ordered that a minimum grant of Rs.3 lakhs to each Village Panchayat shall be provided as a measure of equalization, from out of the Village Panchayats share of 55%. The balance amount shall be distributed based on population.

- 2. In the Government Order second read above, orders have been issued apportioning the Infrastructure Gap Filling Fund as follows:
 - > 50% of Infrastructure Gap Filling Fund allocation to Anaithu Grama Anna Marumalarchi Thittam.

- ➤ Balance 50% of Infrastructure Gap Filling Fund,
 - 25% of balance amount to be retained by Director of Rural Development and Panchayat Raj for providing basic amenities in the Districts.
 - o 75% of balance 50% Infrastructure Gap Filling Fund amount to be allocated to District Collectors based on population and the Collectors to utilize the funds for the same purpose.
- 3. In the Government Order fifth read above, the Government have issued orders that a minimum grant of Rs.30 lakhs will be provided to each Panchayat Union as a measure of equalization and the balance amount shall be distributed based on population, out of the funds allotted to the Panchayat Unions.
- 4. The Commissioner of Rural Development Panchayat Raj in his letter seventh read above has sent the proposal in which he has stated that a sum of Rs.305345.56 lakhs has been provided in the Interim Budget Estimate for 2011-2012 for Rural Local Bodies as State Finance Commission Grant. He has also stated that out of the Village Panchayats share of devolution funds, a minimum grant of Rs.3 lakhs has to be provided to each Village Panchayat as a measure of equalization and the balance amount shall be distributed among the Village Panchayats based on the population. Out of the Panchayat Unions share of devolution, a minimum grant of Rs.30 lakhs has to be given to each Panchayat Union as a measure of equalisation and the balance amount be apportioned to the Panchayat Unions in proportion to population.
- 5. The Government have carefully examined the proposal of the Commissioner of Rural Development and Panchayat Raj in the light of the orders issued in the Government Order first read above and Revised Budget Estimate of Rs.333246.71 lakhs and decided that the State Finance Commissioner Grant shall be distributed as follows:

6. The Government sanction a minimum grant of Rs.3.00 lakhs (Rupees three lakhs only) at the rate of Rs.25,000/- per month to each Village Panchayat in 12 monthly instalments. The Government also sanction the State Finance Commission grant for 10 months from April 2011 to January 2012 to Rural Local Bodies on the basis of 2001 population.

The Government have also decided and sanction a minimum grant of Rs.30.00 lakhs (Rupees Thirty lakhs only) at the rate of Rs.2.50 (Rupees Two lakhs and fifty thousand only) per month to each Panchayat Union in 12 monthly instalments as a measure of equalization and the balance amount shall be distributed on the basis of 2001 population out of funds allotted to the Panchayat Unions as detailed below:

The Commissioner of Rural Development and Panchayat Raj is also requested to make necessary adjustments / deductions for committed expenditure such as pension commitment excess devolution made to Rural Local Bodies from the devolution meant for respective Local Bodies instead of respective tiers while distributing the State Finance Commission devolution grant sanctioned above to the concerned Rural Local Bodies following the orders issued in this regard by the Government after duly reconciling the amount to be deducted with concerned Local Bodies / Heads of Department. The minimum grant sanctioned to Village Panchayats shall be used for payment of Electricity consumption and Water charges so that these services do not suffer.

- 12. The Pay and Accounts Officer / Treasury Officers concerned are requested to admit and honour the bills as and when presented by the Commissioner of Rural Development and Panchayat Raj, if they are found otherwise in order.
