In the Government Order first read above, orders along with detailed guidelines were issued for implementation of "Chief Minister's Solar Powered Green House Scheme" (CMSPGHS) for construction of 3 lakh Solar Powered Green House over a period of 5 years from 2011-12 to 2015-16. In the Guidelines, among others, eligibility for selection of beneficiaries has been indicated and the Commissioner of Rural Development and Panchayat Raj has been authorized to allocate number of houses to be constructed under the scheme for each district in a year.

2) The Commissioner of Rural Development and Panchayat Raj in the letter second above has stated that based on the houseless and requirement for houses in the rural areas in the State level, out of total allocation of 60,000 houses for the year 2011-2012, under the Chief Minister's Solar Powered Green House Scheme" (CMSPGHS), 29% i.e. 17,400 houses may be allotted to the people below poverty line among SCs, 1% i.e. 600 number of houses may be allocated to the people below poverty line among STs, and the remaining 70% of the allocation i.e. 42,000 number of houses may be allocated to other communities (except SC/ST) living below poverty line in rural areas and requested the Government to issue orders for Community-wise allocation of houses under the scheme.

3) The Government have examined the proposal of the Commissioner of Rural Development and Panchayat Raj in detail and decided to accept the same. Accordingly, the Government issue the following orders for community-wise allocation of houses among the beneficiaries under the Scheme.

Out of total allocation of 60,000 houses in a year under the "Chief Minister's Solar Powered Green House Scheme" (CMSPGHS),

- (a) 29% i.e. 17,400 houses are allotted to the people living Below Poverty Line among Scheduled Castes in rural areas.
- (b) 1% i.e. 600 number of houses are allocated to the people living Below Poverty Line among Scheduled Tribes in rural areas.
- (c) The remaining 70% of the allocation i.e. 42,000 number of houses are allocated to other communities (except SC/ST) living Below Poverty Line in rural areas.
