ORDER:

In the Government Order first read above, orders along with the detailed guidelines including sanction of funds were issued for the construction of 60,000 Green Houses under Chief Minister's Solar Powered Green House Scheme (CMSPGHS) during 2011-12.

- 2. The Hon'ble Minister for Finance, while presenting the Budget for the year 2012-13, has announced, among others that during the financial year 2012-2013 another 60,000 houses will be taken-up at a cost of Rs.1,080 crores. Moreover, while replying to the debate on the demand for grants for Rural Development and Panchayat Raj Department on the floor of the Tamil Nadu Legislative Assembly on 9.4.2012, the Hon'ble Minister for MA & RD has also announced, among others, that during 2012-2013, as many as 60,000 Solar Powered Green Houses will be constructed at the cost of Rs.1,080 crores.
- 3. The Commissioner of Rural Development and Panchayat Raj in his letter third read above, among others, has requested the Government to accord financial sanction of Rs.1,087.20 crores including 4% service charge to Tamil Nadu Energy Development Agency (TEDA) and permission for the construction of 60,000 houses

as done during 2011-2012 under Chief Minister's Solar Powered Green House Scheme (CMSPGHS) for the implementation of the Scheme during 2012-2013.

- 4. The Government have examined the proposal of the Commissioner of Rural Development and Panchayat Raj in detail, decided to accept the same and issue the following orders:-
 - (i) Accord financial sanction of Rs.1087.20 crores including 4% service charge to Tamil Nadu Energy Development Agency for the construction of Green Houses under Chief Minister's Solar Powered Green House Scheme (CMSPGHS) during 2012-2013
 - (ii) The Commissioner of Rural Development and Panchayat Raj is permitted to take up 60,000 houses for the construction of houses under the Chief Minister's Solar Powered Green House Scheme (CMSPGHS) during 2012-2013.
 - (iii) Orders regarding guidelines and release of funds for the Chief Minister's Solar Powered Green House Scheme (CMSPGHS) 2012-13, will be issued separately.
- 5. This orders issues with the concurrence of Finance Department vide its U.O. No.27439/RD/12 dated 4.6.2012.
