ORDER:

In the G.O.(Ms) No.46, Rural Development and Panchayat Raj (SGS-I) Department dated 17.8.2011, necessary orders as well as detailed guidelines were issued for the implementation of Chief Minister's Solar Powered Green House Scheme (CMSPGHS) during the year 2011-2012.

2. In the Government Order fourth read above, orders were issued for the financial sanction and the number of houses to be taken up for the year 2012-13 under Chief Minister's Solar Powered Green House Scheme.

3. In the letter fifth read above, the Commissioner of Rural Development and Panchayat Raj has sent draft guidelines for the implementation of the Chief Minister's Solar Powered Green House Scheme (CMSPGHS) with a change over in the mode of the selection of beneficiaries (i.e) Paragraph No.7 of the guidelines issued in the Government Order first read above, taking into consideration the experience gained during the field inspections undertaken by the Additional Directors of Rural Development and by Commissioner of Rural Development and Panchayat Raj in the Districts in the selection of beneficiaries by the Village Panchayats.

The Government have examined the proposal of the Commissioner of Rural Development and Panchayat Raj and issue the following amendments to the Guidelines annexed with the G.O.(Ms) No.46, Rural Development and Panchayat Raj (SGS-I) Department dated 17.8.2011 issued for the implementation of the Chief Minister's Solar Powered Green House Scheme (CMSPGHS) during 2011-2012:-

AMENDMENT

(i) the existing title of para 6 of the Guidelines,

Selection of beneficiaries shall be replaced as

6. Mode of selection of beneficiaries.

(ii) the existing **para 7 "Verification of the beneficiaries"** shall be replaced as

7. Selection of beneficiaries:

From the list of eligible beneficiaries as mentioned above, a Committee comprising of Block Development Officer (Village Panchayats), Deputy Block Development Officer and Village Panchayat President concerned shall select the genuine BPL beneficiary as per Guidelines and the final list of selected beneficiaries identified by the Committee should be placed before the Grama Sabha for its approval. Based on the approval of the Grama Sabha, the Block Development Officer (Village Panchayat) will issue work order to the selected beneficiaries.

(iii) Rest of the Guidelines issued in G.O.(Ms) No.46, Rural Development and Panchayat Raj (SGS-I) Department dated 17.8.2011 shall be followed for the implementation of the scheme for the year 2012-2013.
