## ORDER:

In the Government Order first read above, Orders along with necessary Guidelines were issued for the implementation of the Chief Minister's Solar Powered Green House Scheme and in the Government Order 2<sup>nd</sup> read above, Community-wise reservation in allocation of houses among the beneficiaries under the Scheme were issued.

2) Pursuant to the proposal received from the State Commissioner of Welfare of Differently Abled Persons in the letter 3<sup>rd</sup> read above for providing 3% reservation of houses constructed under the Chief Minister's Solar Powered Green House Scheme to the Differently Abled Persons, in the Government letter 4<sup>th</sup> read above, the Commissioner of Rural Development and Panchayat Raj has been requested to send a suitable proposal thereon. The Commissioner of Rural Development and Panchayat Raj, in the letter 5<sup>th</sup> read above, has sent a proposal to incorporate 3% reservation to allocation of Green Houses for differently able persons and requested the Government to issue necessary orders in this regard.

3) The Government have examined the proposal of the Commissioner of Rural Development and Panchayat Raj and decided to accept the same. Accordingly, the Government issue the following Amendment to G.O. (Ms) No.83, Rural Development and Panchayat Raj (SGS-1) Department, dated 03.11.2011.

## **Amendment**

For the Existing paragraph 3(a), 3(b) and 3 (c) occurring in the said Government Order, the following paragraphs shall be substituted.

Out of total allocation of 60,000 houses, in a year under "Chief Minister's Solar Powered Green House Scheme" (CMSPGHS)

- (a) 29% i.e. 17,400 houses are allotted to the people living Below Poverty Line among Scheduled Castes in rural areas. Out of the 17,400 houses, 3% i.e 522 houses have to be allocated to the Differently Abled Persons living Below Poverty Line among Scheduled Castes in rural areas.
- (b) 1% i.e. 600 number of houses are allocated to the people living Below Poverty Line among Scheduled Tribes in rural areas. Out of the 600 houses, 3% i.e 18 houses have to be allocated to the Differently Abled Persons living Below Poverty Line among Scheduled Tribes in rural areas.
- (c) The remaining 70% of the allocation i.e. 42,000 number of houses are allocated to other communities (except SC/ST) living Below Poverty Line in rural areas. Out of the 42,000 houses, 3% i.e 1,260 houses have to be allocated to the Differently Abled Persons living Below Poverty Line among Other Communities (except SC/ST) in rural areas.
