Sub: Schemes – State Scheme – Construction of Solar Powered Green Houses under "Chief Minister's Solar Powered Green House Scheme" (CMSPGHS) – Implementation of the Scheme during 2012-2013 – Amendment to the Guidelines - Issued.

I am directed to state that the following amendments are issued to

the Guidelines issued in the Government Order first cited:-

<u>Amendment</u>

(i) For the sentence "Each house shall have 5 CFL lights through Solar Photo Voltaic (SPV) System" occurring in paragraph 4 of the Guidelines, the following sentence shall be substituted:-

LED based Home lights shall be installed in One Urbanized district in each of the 4 regions with the following configuration:-

"5 Nos. LED lamps operating for 5 hours a day with one day autonomy (2 nos. 7 W LED each in hall & varendah, 2 nos. 5 W LED each in Kitchen & bedroom and 1 no. 3W LED in Toilet)".

In the remaining districts of 4 regions, the existing 5 nos. 9 W CFL, as carried out in the year 2011-2012 shall be continued.

(ii) For the sentence "The internal wiring will be done as part of the civil construction. Tamil Nadu Energy Development Agency will do upto the change over including the installation of the change over switch" occurring in the paragraph 4 of the Guidelines, the following sentence shall be substituted:-

The Solar wiring shall be under the scope of Tamil Nadu Energy Development Agency and Rural Development and Panchayat Raj Department will provide a separate conduit/pipe for the solar wiring.
