ORDER:-

In the Government Order first read above, permission was accorded for payment of interim arrears to the staff working in Tamil Nadu Corporation for Development of Women Limited.

The Managing Director, Tamil Nadu Corporation for Development of Women Limited in his letter second read above, has stated that the Tamil Nadu Corporation for Development of Women Limited has been adopting the Government pay scales for its employees. Therefore, as and when pay scales are revised by the Government for its staff, the pay scales of Staff working in the Corporation are also revised. He has also stated that the Government had issued orders extending the revised scales to the employees of State Public Sector Undertaking / Boards in G.O.Ms.No.250, Finance (BPE) Department, dated 17.6.2009.

The Managing Director, Tamil Nadu Corporation for Development of Women Limited has stated that, since the Government in Finance Department had instructed to complete the process of fixation of pay before 30.9.2009, the revised scales of Pay and Allowances has been implemented to the employees of Tamil Nadu Corporation for Development of Women Limited notionally from 1.1.2006 with monetary benefit from 1.1.2007, as ordered in the G.O.Ms.No.234, Finance (Pay Cell) Department dated 1.6.2009 and as per the guidelines issued in G.O.Ms.No.250, Finance (BPE) Department dated 17.6.2009. Therefore, he has requested the Government to ratify his action in having implemented the Tamil Nadu Revised Scales of Pay Rules, 2009 and for disbursed the first instalment of arrears to the employees of Tamil Nadu Corporation for Development of Women Limited.

4. The Government after careful consideration of the proposal of the Managing Director, Tamil Nadu Corporation for Development of Women Limited, accept the proposal and ratify the action of Managing Director, Tamil Nadu Corporation for Development of Women Limited in having implemented the Tamil Nadu Revised Scales of Pay Rules, 2009 and disbursed the first instalment of arrears to the employees of Tamil Nadu Corporation for Development of Women Limited.
