In the Government order first read above, the Government had permitted to fill up 60 posts of Assistant Project Officer sanctioned in the above Government Orders for the Tamil Nadu Corporation for Development of Women Limited and District Implementation Units from the open market preferably from Non Government Organisations and other agencies having experience in works related to Self Help Groups by engaging a well experienced Professional Human Resource Agency.

- 3. The Managing Director, Tamil Nadu Corporation for Development of Women Limited in his letter 2<sup>nd</sup> read above, has stated that during 2009-10, apart from implementation of regular schemes like providing Revolving Fund to 70,000 Self Help Groups, credit linkage of Rs.2,400 crores to Self Help Groups and skill development training to 25,000 youth, Tamil Nadu Corporation for Development of Women will give a major thrust to qualitative restructuring of Panchayat Level Federations and forming Economic Activity Federations in all the districts. It is therefore essential to have a dedicated cadre of Assistant Project Officers in the districts who have relevant experience in the areas of social mobilization, credit linkages, capacity building and marketing of Self Help Group products. Considering the requirement of above specific skill sets at the field level, the Managing Director, Tamil Nadu Corporation for Development of Women Limited has requested the Government to permit him to recruit another 33 posts of Assistant Project Officer from the open market in lieu of deputationists.
- 4. After careful examination, the Government have decided to accept the proposal of the Managing Director, Tamil Nadu Corporation for Development of Women Limited and permit him to fill up 33 Assistant Project Officer posts from open market for Tamil Nadu Corporation for Development of Women Limited and its District Units, in addition to the 60 posts already ordered to be filled up from open market in the Government order first read above. These 33 posts shall be filled up on contract basis, with the qualifications and remuneration as already ordered in the Government order first read above and by following the reservation policy of the Government.
- 5. The Government further direct that the recruitment of the above posts of 33 Assistant Project Officer shall be made from the open market, preferably from among the persons having experience in the works related to Self Help Groups in Non Government Organisations and other agencies, by engaging a well experienced professional Human Resource Agency and the remaining 32 Assistant Project Officer posts shall be filled up only on deputation basis, preferably, from Rural Development and Panchayat Raj Department.
- 6. This order does not require the concurrence of Finance Department, as per G.O.Ms.No.519, Finance (Salaries) Department, dated 29.9.1997.
