The Director of Rural Development and Panchayat Raj in his letter fourth read above has stated that the total requirement of funds under Anaithu Grama Anna Marumalarchi Thittam for the year 2007-08 is worked out as below:

The Director of Rural Development and Panchayat Raj has therefore requested the Government for provision of balance sum of Rs.10.4783 crores in the Revised Estimate, 2007-08 under the following Head of account:

ii) 4515-00-800-JP-1602 schemes in the Eleventh Five Year Plan

: Rs.8,38,26,000/-

2. The Government have examined the proposal of the Director of Rural Development and Panchayat Raj carefully. The total amount required for the Anaithu Grama Anna Marumalarchi Thittam 2007-08 is Rs.511.868 crores. Of this, a sum of Rs.461.80 crores has been provided in the Budget Estimate 2007-08. In the Government Order 3<sup>rd</sup> read above, a sum of Rs.39.5897 crores being 50% of the share from the infrastructure gap filling fund provided out of the share of Village Panchayats from State Finance Commission Devolution, has been sanctioned. Hence, there is a balance of Rs.10.4783 crores which has to be sanctioned for the Anaithu Grama Anna Marumalarchi Thittam 2007-08 and this has to be provided from the State funds. The Government have decided to provide this amount in the RE/FMA 2007-08.

3. The Government accordingly sanction the balance amount of Rs.10.4783 crores (Rupees Ten crores forty seven lakhs and eighty three thousand only) for the Anaithu Grama Anna Marumalarchi Thittam for the year 2007-08.

- 4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:

The Director of Rural Development and Panchayat Raj is requested to include this expenditure while sending proposal for Revised Estimate/FMA 2007-08 without fail.
