**ORDER:**

In the Government Order 1<sup>st</sup> read above the Government have issued orders sanctioning a sum of Rs.43.50 lakhs for purchase of additional Desktop Computers and Accessories to the Development Wing of 29 District Collectorates at 3 per office under part II schemes, 2008-09. The Commissioner of Rural Development and Panchayat Raj has reported that as per the G O, Desktop Computers and Accessories have been purchased and supplied to Collectorate (Development Wing) in 29 Districts. The details of expenditure incurred are as follows:-

2. The Commissioner of Rural Development and Panchayat Raj has stated that to upgrade the existing Computer Systems in the Directorate, it is proposed to utilize the unspent amount of Rs.9,03,930/-.

3. The Commissioner of Rural Development and Panchayat Raj has therefore requested to issue necessary orders for the purchase of 15 computers and other accessories as mentioned above for the office of the Directorate of Rural Development and Panchayat Raj from the unspent balance amount of Rs.9,03,930/- available under Part-II scheme for 2008-2009.

4. The Government after careful examination have decided to accept the proposal of the Commissioner of Rural Development and Panchayat Raj. Accordingly, the Government sanction a sum of Rs.9,03,930/- (Rupees Nine lakhs three thousand nine hundred and thirty only) to the Commissioner of Rural Development and Panchayat Raj for the purchase of Computers and other articles mentioned in para 2 above.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

“2515. 00. Other Rural Development Programmes – 001. Direction and Administration – I. Non Plan – AD. Establishment charges of Assistant Director(Panchayats) and Assistant Director (Audit) 76. Computer and Accessories – 01 – Purchase. (DPC 2515 – 00 – 001 – AD – 7616)”.
