ORDER:

In the Government order read above, the Governing Body of the Tamil Nadu State Non Governmental Organizations and Voluntary Resource Centre (TNSNGOs &VRC) was lastly reconstituted.

The Managing Director, Tamil Nadu Corporation for Development of Women Limited, in the letter second read above has stated that the Governing Body lastly reconstituted in January, 2008 is completing one year in Office on 10.1.2009 and that Sr. Jeny Myla, National Officer, Daughters of Mary Immaculate (DMI) mentioned in serial No 8 of the Committee has been transferred to Tanzania and further, the Daughters of Mary Immaculate has stated that the person by name in the post of the National Officer, DMI is transferable and hence, the National Officer, Daughters of Mary Immaculate may be included in her place to represent as one of the members of the Governing Body of Tamil Nadu State Non Governmental organizations and Volunteers Resource Centre. The Managing Director, Tamil Nadu Corporation for Development of Women Limited, has accordingly suggested for the reconstitution of the Governing Body of Tamil Nadu State Non Governmental organizations and Volunteers Resource Centre for the period from 11.1.2009 to 10.1.2010 and to re-examine the composition after a period of one year.

The Government after careful examination of the proposal of the Managing Director, Tamil Nadu Corporation for Development of Women Limited, has decided to accept the same and accordingly direct that the Governing Body for the Tamil Nadu State Non Governmental organizations and Volunteers Resource Centre be reconstituted for the period from 11.1.2009 to 10.1.2010 with the following composition:-
