### ORDER:

2. Sanction is hereby accorded for a sum of Rs.10,00,000/- (Rupees Ten lakhs only) as non-recurring expenditure for the purchase of two Cars in the place of condemnation of existing two vehicles to the Tamil Nadu State Election Commission under Part-II Schemes for 2010-2011.

3. The expenditure sanctioned in para 2 above shall be debited to the following head of account:

5. The Secretary, Tamil Nadu State Election Commission shall follow the existing rules in force for procurement of the vehicles sanctioned in para 2 above.
