- 3. Sanction is therefore accorded for non-recurring, expenditure of Rs.100,00,000/- (Rupees One hundred lakhs only) for construction of office Building for Project Director, District Rural Development Agency, The Nilgiris District under Part II Scheme for the year 2010-2011.
