

Abstract

Rural Development and Panchayat Raj Department – Part II Scheme for the year 2010-2011 Construction of Office Building for Panchayat Development wing in Coimbatore District - Sanction of Rs.25,00,000 - Orders issued.

In Coimbatore District, no Master Complex is available for the Collectorate. The entire Panchayat Development wing consisting of the offices of Personal Assistant (Development), Assistant Director (Panchayats), Assistant Director (Audit) and other offices like Personal Assistant (Noon Meal Programme), Personal Assistant (Small Savings), Secretary, District Panchayat are functioning in the Collectorate Campus in an old dilapidated building constructed in1921 for the erstwhile District Board. The Commissioner of Rural Development and Panchayat Raj has therefore proposed the construction of a new building for the Panchayat Development Wing in the 3rd floor of the existing two storied building of the Collector's office.

- 2. The standing Finance Committee has approved the proposal for construction Office Building for Panchayat Development wing in Coimbatore District at a total cost of Rs.25,00,000 (Rupees Twenty Five lakhs only) under Part II Scheme for the year 2010-2011.
- 3. Sanction is therefore accorded for non-recurring expenditure of Rs.25,00,000 (Rupees Twenty Five lakhs only) for construction of office Building for Panchayat Development wing at Coimbatore District under Part II Scheme for the year 2010-2011.
- 4. The expenditure sanctioned in Para 3 above shall be debited to the following Head of Account.
