ORDER

In the G.O. first read above, the Government have sanctioned a sum of Rs.72.00 lakhs under Part II scheme for the year 2007-2008 for provision of 16 vehicles to the District Level Officers of the Rural Development and Panchayat Raj Department and in the G.O. second read above, the Government have sanctioned a sum of Rs.472.50 lakhs under Part-II scheme for the year 2007-2008 for the purchase of 105, five door, Hard Top vehicles for various field Officers of Rural Development and Panchayat Raj Department. The Director of Rural Development and Panchayat Raj has stated that totally 121 vehicles have been purchased at Director General of Supplies and Disposal(DGSD) rate at the cost of Rs.5,29,25,166/- out of a total sum of Rs.5,44,50,000/- sanctioned as shown below:-

2. The Director of Rural Development and Panchayat Raj has stated further that out of the above mentioned balance amount of Rs.15,24,834/-, three Nos., of five door Hard Top vehicles from among the vehicles listed in G.O.(Ms.)No.1229, Home (Transport.IV) Department, dated 21.12.2006 at Director General of

Supplies and Disposal (DGSD) rates can be purchased at the cost of Rs.12,79,116/-(at Rs.4,26,372/- per vehicle). He has therefore requested that the Government may accord sanction for the purchase of three vehicles from the balance amount of Rs.15,24,834/-

3. The Government after careful examination have decided to accord permission to the Director of Rural Development and Panchayat Raj for the purchase of 3 numbers of vehicles against condemnation. Accordingly, the Government sanction a sum of Rs.12,79,116/- (Rupees Twelve lakhs seventy nine thousand one hundred and sixteen only) for the purchase of 3 (three) numbers of five door Hard Top vehicles, at the rate of Rs.4,26,372/- per vehicle against condemnation, at the Director General of Supplies and Disposal (DGSD) rates.

- 4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

- 5. The Director of Rural Development and Panchayat Raj, Chennai is authorized to incur the expenditure sanctioned in para 3 above.
- 6. Necessary funds for this expenditure shall be provided in R.E./FMA 2008-2009. Pending provision of such funds in RE/FMA 2008-2009, the concerned Pay and Accounts Officer is directed to admit the related bills presented by the concerned Officials, if they are otherwise found in order. The Director of Rural Development and Panchayat Raj is requested to send necessary proposals to Government for including this expenditure in RE/FMA 2008-2009.
