ORDER:

In the Government Order second read above, the Government have accorded Revised Administrative sanction for the construction of office building for the Tamil Nadu State Election Commission at Koyambedu at an estimated cost of Rs.2.13 crores. The Secretary, Tamil Nadu State Election Commission has stated that the Executive Engineer, Public Works Department has informed that out of the sum of Rs.2.13 crores allotted, an expenditure of Rs.1,96,47,019/- was incurred upto 31.3.2009 and the balance amount of Rs.16,52,981/- was surrendered to Government as on 31.3.2009 based on the instructions of the Government. The Executive Engineer has further informed that the main construction work was fully completed and various sub-works/electrical works are executed subsequently and payment for the said works are pending. Therefore, the Secretary, Tamil Nadu State Election Commission has requested the Government to release the surrendered amount of Rs.16,52,981/- during the current year i.e. 2009-2010 pending provision of funds in the Revised Estimate/Final Modified Appropriation 2009-2010.

2. The Government after careful examination of the proposal of the Tamil Nadu State Election Commission accept the same and accords sanction for the release of a sum of Rs.16,52,981/- (Rupees Sixteen lakhs fifty two thousand and nine hundred and eighty one only) towards the payment of sub-works/electrical works taken up in the

newly constructed Tamil Nadu State Election Commission office building at Koyambedu, Chennai.

3. The expenditure sanctioned in para 2 above shall be debited to the following head of account:

“4070 – 00 – CAPITAL OUTLAY ON OTHER ADMINISTRATIVE SERVICES – 800 – Other Expenditure – Schemes in the Eleventh Five Year Plan – II. State Plan – KC. Construction of buildings Controlled by Tamil Nadu State Election Commission – 16. Major works” (DPC 4070-00-800-KC-1605).

4. The Secretary, Tamil Nadu State Election Commission is authorized to draw and disburse the amount sanctioned in para 2 above. He is requested to send the Utilization Certificate to Government and Accountant General, Chennai within the prescribed time.

5. Necessary funds have been provided in Final Modified Appropriation/Final Supplementary Estimate 2009-2010.

6. The Government also direct that the Tamil Nadu State Election Commission shall get necessary permission of the Government for installation of the statue in the premises of the Tamil Nadu State Election Commission office area separately.

7. This order issues with the concurrence of Finance Department vide its U.O. No. 17897/(RD)/2010, dated 30.3.2010.
