## **ORDER:**

In the Government order first read above, Government have authorised Tamil Nadu Cements Corporation Ltd. to procure cement from private manufacturers through open tenders for Rural Development and Panchayat Raj Department works.

- 2. In the Government order third read above, orders have been issued permitting the Tamil Nadu Cements Corporation Ltd. to procure 7 lakh MTs. required additionally for the Rural Development and Panchayat Raj works for the year 2009-10, from the private cement manufacturers through open tenders, for one year from the date of issue of order i.e.6.10.2009.
- 3. In the Government order 4<sup>th</sup> read above, orders have been issued for extending the rate contract period till 5.12.2010 or the finalization of tenders for 2010-11 whichever is earlier.

- 4. The Chairman and Managing Director, Tamil Nadu Cements Corporation Ltd. has stated that the tenders have been floated for procurement of cement from private manufacturers on contract basis, for the year 2010-11, for Rural Development and Panchayat Raj Department works. Out of 12 bidders, 6 firms were short listed. Out of the 6 short list firms, M/s Chettinad Cements, Chennai and M/s Avinja Properties, New Delhi have emerged as L1 bidders @ Rs.230/- per bag, covering all the clusters. After negotiation, the L1 parties agreed to supply the cement @ Rs.210/- per bag inclusive of all taxes, unloading and stacking charges.
- 5. The Managing Director, Tamil Nadu Cements Corporation Ltd. has proposed to place orders with L1 firms M/s Chettinad Cements, Chennai and M/s Avinja Properties, New Delhi at the negotiated rate of Rs.210/- per bag inclusive of all taxes, duties, unloading and stacking of cement bags in the respective Block level office godowns in all clusters, for supply of 5.38 lakh MTs. for one year from the date of approval of the Government.
- 6. After careful examination, the Government accept the proposal of the Managing Director, Tamil Nadu Cements Corporation Ltd. and direct as follows:
  - (i) Tamil Nadu Cements Corporation Ltd. shall place orders with lowest bidders (i.e.) M/s Chettinad Cements, Chennai and M/s Avinja Properties, New Delhi at the negotiated rate of Rs.210/- per bag inclusive of all taxes, duties, unloading and stacking of cement bags in the respective Block level godowns in all clusters, for supply of 5.38 lakh MTs. of OPC 43 Grade cement for one year from the date of issue of order and arrange for regular supply as per requirement of District Rural Development Agencies.
  - (ii) The previous order 4<sup>th</sup> read above, extending the rate contract period for a period of two months is hereby withdrawn.
  - (iii) Payment of service charges to Tamil Nadu Cements Corporation Ltd., orders will be decided separately.
  - (iv) The Tamil Nadu Cements Corporation Ltd. shall conduct quality tests as per IS Code 8112-1989 and they are eligible for claiming inspection / quality test charges in addition to the service charge as ordered in G.O.(2D) No.29, Rural Development and Panchayat Raj Department, dated 15.4.2008. The procedures for inspection / quality test and submission of claims shall be the same as ordered already in the said Government Order.
