ORDER:

In the Government D.O. letter 1st read above, the District Collectors were requested to prepare proposals in conformity with NABARD guidelines for improvement / strengthening of Panchayat / Panchayat Union roads which are in bad condition and lead directly or indirectly to or in the vicinity of the Anaithu Grama Anna Marumalarchi Thittam 2009-10 Village Panchayats and also to propose link roads which are important for the industries, tourism and for marketing of produce from such villages and send the proposals to the Commissioner of Rural Development and Panchayat Raj.

- 2) In the reference 2nd read above, the Commissioner of Rural Development and Panchayat Raj, had sent the consolidated proposal for improvement / strengthening of 769 Panchayat / Panchayat Union Roads to the total length of 2,159.76 KM to the tune of Rs.320.147 Crores, in the Anaithu Grama Anna Marumalarchi Thittam Villages 2009-10 and the proposal have also been forwarded to NABARD in the reference 3rd read above.
- 3) Since there was delay in sanctioning of loan by NABARD and due to urgent need and importance for improving these roads, 357 Panchayat / Panchayat Union road works, falling in the Villages coming under Anaithu Grama Anna Marumalarchi Thittam 2009-10 were taken up utilizing the funds from State sponsored Schemes, out of 769 road works proposed and sent to NABARD for sanction of loan. Consequently, in the reference 5th read above, the Director of Rural Development and Panchayat Raj sent a revised proposal for improvement / strengthening of 748 Panchayat / Panchayat Union Roads for the total length of 2,068.033 KM to the tune of Rs.320.147 Crores, falling in the Village Panchayats covered under Anaithu Grama Anna Marumalarchi Thittam Village Panchayats 2009-10 & 2010-11 and the same was forwarded to NABARD in the reference 6th read above. The project cost of Rs.320.147 Crores, would be met from NABARD's loan component of Rs.256.1176 Crores and the State Government's funds of Rs.64.0294 Crores.
- NABARD has already sanctioned а Rs.159.9918 Crores (80 % of loan) during the current financial year under Infrastructure Development Fund-XVI for upgradation 508 Panchayat / Panchayat Union Roads in the 2008-09 Anaithu Grama Anna Marumalarchi Thittam Village Panchayats (Phase II) and it is felt that sanctioning of an another loan by the NABARD may be delayed. But, it is necessary to carry out these works urgently. Hence, considering the urgency to take up the road works, as given in the Annexure, the Government accord administrative sanction for sum Rs. 320,14,70,000/- (Rupees Three Hundred and Twenty Crores and Fourteen Lakhs and Seventy Thousand only) for improvement / strengthening of 748 Panchayat / Panchayat Union Roads falling in the Village Panchayats covered under Anaithu Grama Anna Marumalarchi Thittam of 2009-10 and 2010-11, in anticipation of approval of the project under NABARD.

5) The Government also direct that the amount of Rs.320,14,70,000/- sanctioned in para 4 above shall be debited under the following heads of account: -

However, this expenditure shall be brought to the notice of the Legislature by Specific inclusion in the Supplementary

Estimates. The Director of Rural Development and Panchayat Raj is also requested to send necessary draft explanatory notes to Government in Finance (BG.I/RD & PR) Department for inclusion of the expenditure in the Supplementary Estimates, 2010-2011.
