

11.3 Revised Guidelines and allocation of funds for 1994-95

ORDER

In the Government Orders first and 2nd read above instructions were issued and sanction was accorded for implementation of Decentralised District Planning at District level during 1993-94.

2. Based on the experience gained at field level, the State Planning Commission in its references 3rd and 4th read above, has proposed Revised Guidelines for implementation of Decentralised District Planning with the twin aims of better implementation of the Plan Schemes at field level and of percolation benefits to the public.

3. Based on the suggestions received from the State Planning Commission, the following Revised Guidelines are issued for preparation of District Plans and execution of works during 1994-95.

- i) The list of activities which can be supported under District plans shall be modified and expanded as in Annexure-I. The estimated cost of any work shall not exceed rupees five lakhs.
- ii) Outlays on roads and bridges shall be restricted to allocation for the district.
- iii) Outlays on schemes entrusted to the Panchayat Unions for implementation shall be limited to 50% of the total allocation for the District.
- iv) With the above modifications the guidelines regarding preparation, approval, sanction of expenditure execution of works and monitoring of implementation, already issued in the Government Orders first and second read above shall be followed during 1994-95 also.

4. All Collectors and all Project Officers of District Rural Development Agencies are instructed to follow these guidelines while formulating and implementing district plans for 1994-95. The Project Officers are instructed to maintain the prescribed registers and send reports to the State Planning Commission and Director of Rural Development as already prescribed in the Government Orders cited.

5. Sanction is accorded for drawal of a sum of Rs.40.00 crores (Rupees forty crores) only as "Untied Fund" towards Decentralised District Planning in all the Districts except Madras. Of this, an amount of Rs.10/- crores (Rupees Ten Crores) only shall be distributed among all districts except Madras with reference to performance in collection of Small Savings as per a formula suggested by the Finance Department. The balance of Rs.30 crores (Rupees Thirty crores) only shall be distributed among all districts except Madras with reference to population, area and index of backwardness as per a formula suggested by the State Planning Commission. Allocation of the total amount of Rs.40 crores among districts shall be as in Annexure-II to this order.

6. Out of Rs.40 crores sanctioned in par 5 above, a sum of Rs.30 crores (Rupees thirty crores) shall be debited to the sub-head of account "JF. Assistance to Local Bodies for District Decentralised Plan-09. Grants-in-aid (D.P.Code No.2515.00.101.JF 0903) and the balance amount of Rs.10 crores (Rupees Ten crores) shall be debited to the sub-head of account "JG. Assistance

for Decentralised District plan linked to performance under Small Savings-09 Grant-in-Aid (D.P.Code No.2515.00.101.JG.0901)" under the major head 2515-Other Rural Development Programmes-101 Panchayat Raj- Schemes in the Eighth Five year Plan-II State Plan" respectively. The amounts sanctioned above shall be met by re appropriation of funds within the grant.

7. The District Collectors are authorized to draw the amount sanctioned in the annexure-II to the Government Order and credit the same to the account of the District Rural Development Agency from which expenditure may be incurred on individual schemes sanctioned on the basis of the approved district plan. The District Collectors are requested to report to the Member Secretary, State Planning Commission/ Director of Rural Development about the amount drawn by them with reference to the sanction.

ANNEXURE-IDECENTRALISED DISTRICT PLAN – 1994-95
TYPES OF WORKS WHICH CAN BE TAKEN UP.

1. Construction/ Renovation of Primary/ Middle/ High/ Higher Secondary/ School Building including provision of toilet facilities with water supply;
2. Construction/ renovation of Noon-meal Centers including kitchen shed with store room with provision of water supply.
3. Construction of dispensaries, Health sub-centres including Siddha/ Homeopathy/ Ayurveda/ Unani.
4. Construction of culverts, bridges, footpaths, cart-cum-foot bridges, pedestrian pathways, formation of roads, improvement of roads and Black Topping.
5. Construction of Bathing ghat, retaining wall, revetment.
6. Providing protected water supply.
7. Laying and improving drainage system and low cost sanitation programme.
8. Desilting of Tanks (including tanks belonging to places of worship) Panchayat ponds, check dams, supply channels and standardization of minor irrigation tanks, strengthening of tank bund and repairing of sluice, weir and vent.
9. Afforestation programme in Government lands, Government/ Local Body Schools/ Colleges, Government Institutions;
10. Rehabilitation of degraded forests and cultivable waste lands including water supply arrangements and live fencing;
11. Fodder Development Programme;
12. Construction of Buildings for Veterinary dispensaries, sub-centres, artificial insemination centres;
13. Fisheries development – improvement of inland fisheries – providing infrastructure facilities in coastal villages, Fishermen hamlets and formation of fish drying yards in coastal areas;
14. Taking up Anti-Sea Erosion measures in coastal areas and Anti Wind Erosion measures in affected areas;
15. Development of Khadi and Village Industries.
16. Development of sericulture, Construction of Chawki Rearing Centre, Reeling Centre;
17. Construction/ improvement of pathway to burial grounds/ grave-yards with provision of shed with water supply;
18. Construction of new library buildings, reading rooms, Study Rooms provided land is donated by local bodies or by philanthropists;
19. Improvement of Shandies and markets by construction of platform with tin sheet roof and providing toilet facilities with water.

20. Construction and improvement of slaughter houses;
21. Construction of Balwadi and crèches to help working women/ women labourers;
22. Construction of threshing floors in Govt./ Panchayat land or in private land provided the land is donated for community purpose;
23. Construction of bus shed, shelter.
24. Construction and renovation of existing Rural Extension Training Centres.
25. Construction of Community Centre, Common work shed for rural artisans, weavers, Development of Women and Children in Rural Area groups etc.,
26. Slum improvement works like providing street lights, Water Supply, pathways, construction of toilets etc.,
27. Construction of Public convenience and bathrooms with provision of water supply;
28. Provision of street lights and handpumps and formation of streets in the Harijan colonies constructed under JVVVT.
29. Construction of Dhobikhanas and providing infrastructure facilities to Dhobikhanas.
