11.2 Guidelines for implementing the Decentralised District Plan

ORDER

The Government have decided to give special emphasis to decentralized planning at the District level. The District Development Council will be entrusted with the responsibility of preparing the District Plan. Micro- level –plants at the block level and at the Panchayat Level will be integrated with the District Plan.

2. Accordingly in the reference first read above orders have been issued on the broad features of the schemes, implementing agency and allocation of Untied funds for Decentralised District Planning.

3. In the reference third read above, the State Planning Commission has proposed certain guidelines for formulation and implementation of the Decentralised District Plans.

4. The Government after careful consideration have accepted the proposals of the State Planning Commission with certain modifications. They accordingly issue the guidelines for Decentralised District Planning for the year 1993-94 as given in the Annexure – I to this Government Order.

5. All Collectors and all Project Officers (District Rural Development Agency) are instructed to follow these guidelines while formulating and implementing District Plans for 1993-94. The Project Officers are instructed to maintain prescribed register and send reports to the State Planning Commission and the Director of Rural Development as prescribed in the guidelines.

6. This order issues with the concurrence or Finance Department vide its U.O.No.4943/ FS/P/93 dated. 26.8.93.

ANNEXURE I

GUIDELINES FOR DECENTRALISED DISTRICT PLANNIJNG – 1993 -94

(I) INTRODUCTION

Decentralised District Planning has been launched in all the districts in Tamil Nadu for the first time in the Annual Plan 1993-94 and the decision in this regard was announced in 1993-94 Budget Speech of the Hon'ble Finance Minister. Earlier, the proposal for introducing Decentralised District Planning was considered in the meeting of the State Planning Commission, presided over by the Hon'ble Chief Minister in October, 1992. The Hon'ble Chief Minister in her address has made a pointed reference to this subject and said that "We have to make a new headway by giving responsibility and ensuring accountability at the district level. We have to consider proposals for formulation of district plan with the scope for district sector, where decision making can be decentralized." The present proposal for Decentralsied District Planning is the first step towards achieving the cherished objectives of the Hon'ble Chief Minister.

2) SCOPE OF THE DISTRICT PLAN

District Planning is a kind of area based planning with a more detailed assessment of the resources, problems and potentials of the district, so that investment programme and welfare oriented schemes which are well suited to the particular needs of the district could be evolved. Ideally, district planning should cover all aspects of socio-economic life of people living in the area and also the management of the natural resources in the district. As we are introducing district planning concept in the midst of a development process we have to define clearly the scope of district planning and delineate the specific subjects of district planning. A practical point of view is that we may have to restrict the planning to activities and sectors which we describe as 'local sector' or 'district and the flow of benefits largely confined to the district or only to a cluster of villages. For example, overhead tanks for water supply, primary school, link roads fall under the category of district sector. Schemes whose benefits extend beyond the boundaries of a district are classified as State Sector Scheme for example, State High ways, medium irrigation and power generation schemes. By applying these criteria, it is possible to classify all the plan schemes under two categories namely, District Sector and schemes under two categories namely, District Sector, and State Sector. The ultimate objective is to entrust planning activities in respect of district sector to the district planning agency. During the transition stage some overlapping of functional responsibility will be there and this could be eliminated in a phased manner. The principle of differentiating planning function in relation to different geographical levels on the basis of specific incident of benefits has a district advantage in planning. It lends precision to planning methodology and avoid overlapping of functions. This classification also facilitates the determination of financial needs of district sector separately.

3) METHODOLOGY

It would be necessary to initiate steps for preparation of a comprehensive district plan. The following steps are suggested for preparation of a comprehensive district plan.

- 1) Formulation of the major objectives of the district plan.
- 2) Compilation of data for district planning.
- 3) Bringing out the profile of the district in relation to the basic objectives.
- 4) Formulating the main strategy and thrust of district planning'
- 5) Analysis of the existing programmes and projects with reference to the strategy outlined above and proposals regarding.
 - a) Modification of the ongoing programmes and projects.
 - b) Proposals for removal of inter-block disparities.
 - c) Assessment of unemployment/under –employment and proposals for man-power planning and budgeting.

- d) Inclusion of new projects and plans.
- e) Inter linkages between various projects and programmes.
- f) Organisation and management to ensure that no implementation gap exists.
- 6) Assessment of resources for allocation to various programmes and projects.
- 7) A statement of physical and financial components of the district plan.
- 8) Statement of spatial dimension of the district plan.
- 9) Relationship and links between the District Plan and Regional and State Development Plans.

To begin with, District plan would be prepared for the sectors and activities indicated in the Annexure – B for the year 1993-94; having regard to the allocation made to the district. (Annexure – A). Simultaneously, remaining years (94-95, 95-96 and 96-97) of the Eight Five Year Plan. The Budget allocation can tentatively be assumed to increase by 20% every year. The DRDA must endeavour to assemble reports/studies/surveys pertaining to the districts conducted by the Agriculture University, Financial Institutions, Small Industries Service Institute and various State Government Departments. The information contained in these documents and their findings should be utilized for the documents and their findings should be utilized for the formulation of district plan. In particular, the following survey/ reports provide useful information for planning:

- (1) The information collected for the DISNIC survey by the Assistant Director of Statistics and the district NIC officers.]
- (2) Survey of basic amenities conducted by Education, Health, Social Welfare, Highways Departments and TWAD Board, The results of the surveys are available with above organizations and may be used for deciding on the provision of basic amenities.
- (3) The TamilNadu Agriculture University, Coimbatore has prepared techno-economic surveys and Agro- Climatic regional plans for some districts. These surveys and plans have identified the potentials in agriculture and allied sectors. The findings and recommendations contained in those surveys/Plans may be used I the formulation of the District Plan.
- (4) Reports prepared by District Industries Centres, Small Industries Service Institute and Industrial Technical and Consultancy Organisatin of Tamil Nadu. (ITCOT)
- (5) Potential- linked credit plan prepared by NABARD and credit plans prepared by Lead Banks.
- (6) The results of Census 1991.

4) DISTRICT PLAN FOR M 1993-94 : FORMULATION & APPROVAL

The District Rural Development Agency will prepare an Annual Plan for 1993-94 based on the following:

(i) District Planning should start from below. Panchayat Union Commissioners may be asked to formulate proposals for their Union, after reviewing the requirements of each village and also in consultation with local people, local representation, MLA's, MP's etc. The recently conducted DISNIC survey indicates the availability or non-availability of basic infrastructure in each village. This may be verified by discussion in the concerned villages and proposals prepared, to take up works to satisfy felt needs of the villagers. Stipulations in the G.O. regarding the type design and cost may be adhered to. Where the work needed in the village is of a type not executed by the Kattida Maiyam or Panchayat Union, but only by line departments, proposals for executing such works may be obtained from the departments concerned. Such village –wise proposals may be consolidated for the Block, prioritiesed and sent to the Project Officer, DRDA.

- (ii) Requests received already from the public in respect of certain schemes of local importance, which are under consideration, either in the Collectorate or District Rural Development Agency, may also be considered for the District Plan for 1993-94, provided they conform to the guidelines.
- (iii) Total cost of the schemes proposed for 93-94 may be kept about twice the amount allocated to the District. This would facilitate the DDC to select the schemes which are to be finally included in the Plan.
- (iv) The Project Officer, DRDA may prepare a list of schemes for inclusion in the District Plan 1993-94, after careful consideration of the proposals as per (i), (ii), and (iii) above and priorities them from the District level perspective. The list of schemes recommended by Project Officer, DRDA may be circulated to all official and non- official members of District Development Council
- (v) The District Development Council may discuss finalise and approve the District Plan and the individual schemes to be taken up. The view of departmental officials if any, on technical feasibility of schemes proposed should also be given due consideration in the meeting. The total cost of the schemes finalized in the DDC meeting should be kept within the allocation made for the district.
- (vi) To the extent possible, it may be ensured that the allocation made under the District Plan is spread over in as many Panchayat Unions, as possible. Efforts should be made to complete all the works within this financial year itself (i.e before 31 st March 1994).
- (vii) The District Plan for 1993-94, approved by the District Development Council, should be communicated (Annexure C) to the State Planning Commission.

5) FINANCIAL SANCTION FOR IMPLEMENTING SCHEMES (FOR 1993-94)

After approval of the District Plan by the DDC the respective District Collectors are empowered to accord administration sanctionn to individual works upto Rs.5.00 (Five) lakh, included in the District Plan without further reference toe the Government.

6) AGENCY FOR IMPLEMENTATION AND TECHNICAL SANCTION

1) The District Plan Schemes would be implemented by the Kattida Maiyam / Non-Governmental Organisation/ Line departments or the regular Panchayat Union Commissioner. The Collector shall decide on the implementing Agency. Collector shall entrust the work to the Kattida Maiyam in the district, wherever such Maiyam exist and the works can be executed by the Maiyam. For implementing works which cannot be taken up by Kattida Maiyam; a Line Departments may be considered. Only works which cannot be executed by Kattida Maiyam; a Line Department will be executed by the regular Panchayat Union Commissioner through a contractor, after following tender procedure. Works which cannot be taken up by any of the above agencies, may be entrusted to Non-Government or Voluntary agencies.

2) In case of schemes entrusted to them, Kattida Maiyams shall adopt the usual technical and financial procedure followed by them. In respect of schemes entrusted to Government departments, the existing technical and financial procedures for execution of works should be followed for District Plan Schemes also. In case of schemes entrusted to Non – Governmental Organisation the procedure hither to followed by DRDA for implementation of schemes through Non-Governmental Organisation should be followed. The Collector must satisfy himself/herself about the credibility and capability of the Non Governmental Organisations before entrusting the works to them. The name of Non- Governmental Organisation /details of works under District Plan entrusted to them for implementation should be communicated to the State Planning Commission.

7) ACCOUNTING

i) Financial sanctions and expenditure on each work should be maintained in a separate register, by the Project Officer, District Rural Development Agency.

11. DDP

ii) Accounting and auditing procedures followed in implementing plan schemes by the Panchayat Union /Line Department, would be followed in respect of District Plan Schemes also.The Project Officer, District Rural Development Agency shall be responsible for scrutiny and passing of bills, release of funds, accounting and audit.

8) MONITORING

- i) Physical progress should also be watched at the field level and both physical and financial progress are to be reviewed once a in a month, along with monthly review of plan schemes by the Collector.
- Quarterly physical and Financial review reports should be sent in the Format enclosed (Annexure D) by the Project Officer, District Rural Development Agency to the Commissioner of Rural Development and Member – Secretary of the State Planning Commission.
- iii) Project Officer, District Rural Development Agency will take up monitoring the District Plan Schemes. For this purpose, the Project Officer may utilize the services of Assistance Project Officer (Monitoring) in particular, as well as other Assistant Project Officers, depending on necessity and urgency. At the State level, the State Planning Commission will monitory the schemes in coordination with the Commissioner for Rural Development,.

9) GENERAL

These guidelines are applicable only for the year 1993-94 and would be revised for the subsequent years based on a review of working of the scheme.
