### 1.48 2005-06 - Construction of quarters for Project Officers, DRDA of Cuddalore, Krishnagiri and Thoothukudi - Release of balance funds of Rs.28.80 Lakhs

#### ORDER

In the Government Order 1st read above, Government have sanctioned an ultimate cost of Rs. 48.00 lakhs under part II Scheme 2005-06 for the construction of official quarters with camp office to Project Officer/ Additional Collector (Dev), District Rural Development Agency at Cuddalore, Krishnagiri and Thoothukudi Districts. The Government have also sanctioned a sum of Rs.19.20 lakhs (Rs.6.40 lakhs to each District) during the year 2005-06, for construction of official quarters with camp office to Project Officer/Additional Collector (Dev) District Rural Development Agency, Cuddalore, Krishnagiri and Thoothukudi.

2. The Director of Rural Development and panchayat Raj has now requested the Government to release the balance amount of Rs.28.80 lakhs (Rs.9.60 lakhs for each district) during the year 2006-07, so as to complete the above building early. He has added that necessary budget provision has already been made in BE for 2006-07 under the Head of account "4515-00-103 - JB - 1608".

3. The Government accept the above proposal of the Director of Rural Development and Panchayat Raj and accordingly sanction a sum of Rs.28.80 lakhs (Rupees Twenty eight lakhs and eighty thousand only) (Rs. 9.60 lakhs for each District) for construction of official quarters with camp office to Project Officer/Additional Collector (Dev), District Rural Development Agency at Cuddalore, Krishnagiri and Thoothukudi Districts.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

"4515-00- capital outlay on other Rural Development Programmes - 103 - Rural Development - Schemes in the Tenth Five year plan - II State Plan - JB construction of Office Building for Project Office (Accounts) District Rural Development Agency - 16 Major Works" (DPC 4515-00-103-JB 1608).

5. The Director of Rural Development and Panchayat Raj is permitted to execute the above work and is authorised to draw the above amount and disburse the same.

6. A report of completion of the Building works and utilisation of the amount shall be submitted to Government within the prescribed time. The utilisation certificate shall also be furnished to the Accountant General, under intimation to Government. Unspent balance / savings if any be refunded to the Government account, before the end of the Financial Year.
