**ORDER**

In the Government Order first read above orders have been issued to construct staff quarters at Javadhu Hills under Part II Scheme at an estimated cost of Rs.15.84 lakhs during the year 2001-02 and the Director of Rural Development is authorized to draw the above advance amount and disburse the same to the Collector of Tiruvannamalai District.

2. In the Government Order second read above, an amendment has been issued to the Government Order first read above, authorising the Chief Engineer (Buildings), Public Works Department to execute the works and to send necessary budget proposals to the Government to make necessary provisions under the relevant component to incur the expenditure and was also requested to send necessary proposals in this regard to Finance Department at the appropriate stage. But the work was not executed by the Public Works Department and the same had been done by the Directorate by Rural Development.

3. As the work was executed by Rural Development Engineering Wing, Javadhu Hills, the Chief Engineer (Buildings), Public works Department has requested that necessary amendment may be issued authorizing the Director of Rural Development to incur the expenditure for the above work. The Director of Rural Development has also requested in the reference fourth read above to issue orders to release the above said amount.

4. In the circumstances stated by the Chief Engineer (Buildings) and the Director of Rural Development above, sanction is hereby accorded for incurring an expenditure of Rs.15.84 lakhs (Rupees fifteen lakhs and eighty four thousand only) for paying the amount to the contractors for construction of Residential Quarters for staff of Block Development Office at Javadhu hills in Tiruvannamalai District.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:

"4515-capital outlay on other Rural Development Programmes - 103 Rural Development Schemes in the Tenth Five Year Plan - II State Plan-JB-Construction of office Building for Project Office (Accounts) District Rural Development Agency - Major Works (DPC 4515-00-103-JB 1608)"

6. Necessary funds will be provided in RE/FMA 2006-07. Pending provision of funds in RE/FMA 2006-07, the Director of Rural Development is authorized to draw and disburse the amount sanctioned in para 4 above to the contractors. He is also requested to include this expenditure while sending proposals for RE/FMA 2006-07 without fail.
