ORDER

In the letter read above, the Director of Rural Development, Madras has sent proposal for construction of staff quarters for Block Development Officers in Keelaiyur Panchayat Union in Nagapattinam Quid-E-Milleth District, S. Pudur Panchayat Union in Pasumpon Muthuramalinga Thevar District at a cost of Rs.4 lakhs each and also for the construction of staff quarters for the two blocks in Nilgiris District at a cost of Rs.16.50 lakhs each.

2. The Standing Finance Committee has approved the scheme for the construction of staff quarters for Block Development Officers in Keelaiyur Panchayat Union in Nagapattinam Quid-E-Milleth District, S. Pudur Panchayat Union in Pasumpon Muthuramalinga Thevar District at a cost of Rs.8 lakhs and also for construction of 2 staff quarters for the two blocks in Nilgiris District at a total cost of Rs.33 lakhs.

3. Accordingly, Rs,24.50 lakhs (Rs.8 lakhs for S.Pudur and Keelaiyur Panchayat Unions and Rs.16.50 lakhs for one block in Nilgiris District) has been provided in Budget Estimate for the year 1994-95. The remaining cost for the construction of one staff quarters in Nilgiris District works out to Rs.16.50 lakhs. The Standing Finance Committee has already mentioned that the additional cost of Rs.16.50 lakhs for the the construction staff quarters in Nilgiris District may be met under the funds available in Hill Area Development Programme.

4. After careful consideration, sanction is hereby accorded for the construction of staff quarters in Keelaiyur Panchayat Union in Nagapattinam Quid-E-Milleth District, and S. Pudur Panchayat Union in Pasumpon Muthuramalinga Thevar District at a total cost of Rs.8 lakhs(each Rs.4 lakhs) during 1994-95.

5. Sanction is also accorded for the construction of two staff quarters in Gudalur and Kothagiri Panchayat Union in Nilgiris District at a total cost of Rs.33 lakhs Out of this, sanction is accorded for incurring an expenditure of Rs.16.50 lakhs only during 1994-95 for the construction of staff quarters in the above two Panchayat Unions. The remaining amount of Rs.16.50 lakhs will be provided under Hill Area Development Programme fund during 1995-96.

6. The Director of Rural Development is requested to take necessary action for sanction of the site and other estimate for construction of two staff quarters in Gudalur and Kothagiri in Nilgiris District in consultation with the Project Director, Hill Area Development Programme, Uthagamandalam and forward to the Government in Planning & Development Deaprtment for allocating the balance of Rs.16.50 lakhs under Hill Area Development Programme fund during 1995-96.

7. The Director of Rural Development is authorised to draw the above amount and disburse the same to the Collectors concerned before 31.3.95. The expenditure sanctioned in paras 4 & 5 above shall be debited to the following head of account:
