## **ORDER**

In his letters read above, the Director of Rural Development has proposed, among others, to construct new lavatory for women staff in Thanjavur and Madurai Collectorates (Panchayat Development Wing) at a cost of Rs.1.30 lakh(Rupees One lakh and thirty thousand only) and cycle stand and jeep sheds in Thanjavur and Chengaplpattu M.G.R District Collectorates(P.D.Wing) at a cost of Rs.3.75 lakhs(Rupees three lakhs and seventy five thousand only) under the part-II Schemes 93-94. The proposal has been approved by the Standing Finance Committee and by the Legislature.

- 2) Sanction is, hereby, accorded for incurring an expenditure of Rs.5.05 lakhs (Rupees Five lakhs and five thousand only) as indicated below:-
  - (i) Lavatory for women staff members in Collectorates of Thanjavur and Madurai Districts (P.D. Wing) (Thanjavur Rs.1.00 lakh and Madurai Rs.0.30 lakh)
  - (ii) Cycle shed and Jeep shed in Collectorates of Thanjavur and Chengalpattu M.G.R. Districts (P.D.Wing) (Thanjavur Rs.1.00 lakh and Chengalpattu M.G.R. District Rs.2.75 lakhs)

- 5) A report of completion of construction of new lavatory for women staff in Thanjavur and Madurai Collectorates and provision of cycle and jeep sheds for Thanjavur and Chengalpattu M.G.R. District Collectorates and utilisation of the grant should be submitted to the Government in due course.
