#### ORDER

The following Para No.10 substituted in the Government Order 2nd cited for Para No.10 of the Government order 1st cited shall be deleted.

The Director of Rural Development and Panchayat Raj is authorized to draw the above amount as an advance under Article 99 of Tamil Nadu Financial Code Volume. I and disburse it to the Managing Director, Tamil Nadu Corporation for Development of Women Limited, Chennai-32.

The Managing Director, Tamil Nadu Corporation for Development of Women Limited is directed to render relevant statement of accounts to the Director of Rural Development as soon as the training programme is over so as to enable the Director of Rural Development to adjust the advance drawn with proper vouchers immediately after completion of the training within the stipulated time as prescribed in the Tamil Nadu Financial Code Volume-I. If any failure in the adjustment of temporary advance drawn, responsibilities shall be fixed against the official concerned for the lapse and suitable action shall be initiated by the competent authority and to send a report to the Government at appropriate stage.

2.The following head of account shall be substituted for the head of account occurring in Para No.9 of the Government order 1st cited.
