## ORDER

In G.O.(Ms.) No.146, Rural Development dated 6.5.97 Government sanctioned an amount of Rs.5.00 lakhs(Rupees five lakhs only) for the construction of residential quarters to Block Development Officers in Coastal Block of Ramanathapuram for the year 1997-98 under Part II Scheme out of an ultimate of Rs.11.50 lakhs (Rupees Eleven lakhs and fifty thousand only).

- 2. The above work was taken up for execution. The Superintending Engineer (Buildings), Madurai has sent proposal for revised administrative sanction for a sum of Rs.8.92 lakhs for the completion of the construction of the said building. The Director of Rural Development has, also recommended the above proposal to Government for Revised administrative sanction for Rs.8.92 lakhs for the construction of Block Development officers quarters at Ramanathapuram.
- 3. After careful consideration, the Government accord revised administrative sanction for Rs.8.92 lakhs(Rupees eight lakhs and ninety two thousand only)towards the construction of Block Development officers quarters at Ramanathapuram.
- 4. The expenditure sanctioned in para 3 above shall be debited to the following head of account.
  - "4515 00 Capital outlay on Other Rural Development Programmes -102 Community Development Schemes in the Ninth Five Year Plan II. State Plan JA Buildings 16. Major Works" (DP.Code No.4515 00 102 JA 1602) "
- 5. Necessary additional provision of Rs.3.92 lakhs (Rupees Three lakhs and Ninety Two Thousand only) will be provided in the Revised Estimate / Final Modified Appropriation 1999-2000 and pending such provision the Director of Rural Development, Chennai is authorised to draw and disburse the amount to the Collector concerned for the completion of the above construction work. The Director of Rural Development Chennai is requested to include this amount while sending proposals for Revised Estimate / Final Modified Appropriation 1999-2000 without fail to Government in Finance (PWD) Department.
- 6. A completion report of the building works and an Utilisation Certificate of this amount should be submitted to the Government within the prescribed time.
- 7. This order issues with the concurrence of the Finance Department vide its U.O. 64/ JS(SKS)/2000-1dated 9.2.2000.
