ORDER

There are 5 Regional Institutes of Rural Development at S.V.Nagaram, T.Kallupatti, Krishnagiri, Pattukottai and Bhavanisagar. 12,618 Village Panchayat Presidents/Vice Presidents, 385 Panchayat Union Chairpersons/Vice Chairpersons, 29 District Panchayat Chairpersons/Vice Chairpersons, staff members of the Rural Development and Panchayat Raj Department and Self Help Group members are given training in these 5 Regional Institutes of Rural Development. Since many of the training Programmes are residential in nature there is a pressing need for proper hostel facilities. But the buildings are in dilapidated condition because repairs and maintenance have not been taken up for a long time. So it was proposed to provide new hostel with good furnished rooms, modern dining hall and modern kitchen for each Regional Institute of Rural Development at an ultimate cost of Rs. 250/- lakhs @Rs.50/- lakhs per Regional Institute of Rural Development.

2. The Standing Finance Committee approved the proposal for construction of hostel buildings, modern dining hall and modern kitchen in the 5 Regional Institutes of Rural Development at S.V. Nagaram, T. Kallupatti, Krishnagiri , Pattukottai and Bhavanisagar at a total cost of Rs. 150.00 lakhs (Rupees One hundred and fifty lakhs only) during 2007-2008.

3. The Government therefore accord sanction for the construction of hostel buildings, modern dining hall and modern kitchen to the 5 Regional Institutes of Rural Development located at S.V. Nagaram, T. Kallupatti, Krishnagiri , Pattukottai and Bhavanisagar at the total cost of Rs. 150.00 lakhs (Rupees One hundred and fifty lakhs only)

4. The Expenditure sanctioned in Para 3 above shall be debited to the following Head of Account:

"4515.00 Capital outlays on other Rural Development Programmes 800 other Expenditure Schemes in the Eleventh Five Year Plan – II State Plan JJ - Construction of office buildings – Executed by Director of Rural Development -16- Major works. (DPC No.4515.-00-800-JJ-1604)"

5. The Director of Rural Development and Panchayat Raj (Trg), Chennai-15 is authorized to draw and disburse the amount sanctioned in Para 3 above. The Director of Rural Development of and Panchayat Raj (Trg) is also directed to initiate necessary steps for construction of hostel buildings, modern dining hall and modern kitchen in the 5 Regional Institutes of Rural Development and to send the utilization certificate to the Government
