

1.57 2007-08 - Provision of 2 Heavy Duty Photo Copiers to Directorate of Rural Development and 414 Photo copiers and 414 Fax Machines to 29 Assistant Directors (Audit) and 385 Panchayat Unions at a cost of Rs.2.92 Crores

ORDER

Various Central and State Schemes are implemented annually throughout the State by the 12,618 Village Panchayats and 385 Panchayat Unions and 29 District Panchayats. Weekly and monthly periodicals and Physical and Financial progress reports and proposals have to be sent from various offices to the State Government and Central Government. These tasks involve taking of multiple copies of the reports. The Director of Rural Development and Panchayat Raj sent the proposals for the provision of 414 Photocopiers and 414 Fax Machines one each for the 29 Offices of Assistant Director (Audit) and 385 Panchayat unions besides 2 heavy Duty Photo Copiers to the Directorate of Rural Development and Panchayat Raj on estimated cost of Rs.292 lakhs under part II Schemes.

2. The State Planning Commission discussed the proposal under Part II Scheme for the year 2007-08 of Rural Development and Panchayat Raj Department on 12.1.07 and cleared above Schemes for placing before the standing Finance Committee The Standing Finance Committee approved the proposal for provision of Heavy Duty Photo Copiers, Photo Copiers and fax machines referred to in Para 1 above at the cost of Rs.292.00 lakhs under Part II Scheme for the year 2007-08.

3. Sanction is therefore accorded for non-recurring expenditure of Rs.292.00 lakhs (Rupees two crores and ninety two lakhs only) for purchase of 2 Heavy Duty Photo Copiers to Directorate of Rural Development and Panchayat Raj, 414 Photo Copiers and 414 Fax Machines to the offices of Assistant Director (Audit) of 29 Districts and 385 offices of Panchayat Unions under Part II Scheme for the year 2007-08.

4. The expenditure sanctioned in Para 3 above shall be debited to the following head of account.

5. The Director of Rural Development and Panchayat Raj Chennai, is authorized to draw and incur the amount sanctioned in Para 3 above. He is requested to send the utilization Certificate to Government within the prescribed time.

6. The Director of Rural Development is directed to follow the existing tender and codal procedures while procuring Heavy Duty photo copiers, photo copiers and fax machines.
