ORDER

In 1997-98 budget, Hon'ble Chief Minister introduced a new Scheme called "Anna Marumalarchi Thittam". This scheme was implemented in 212 village panchayats. The Anna Marumalarchi Thittam was continued in 1998-99 and 212 more village panchayats were covered. In the Government Order first read above detailed guidelines were issued for implementation of this scheme in 1997-98 and in Government Order second and third read above this continued scheme guidelines for 1998-99 were issued. In the D.O. letter fourth read above the Director of Rural Development was requested to send his views for implementation of the scheme in 1999-2000, which were received in the letter fifth read above. Government have decided to continue the scheme in 1999-2000.

2. The objective of the scheme is to develop the selected village panchayats with facilities for better infrastructure and quality of life. Each Member of the Legislative Assembly, in the rural constituency will select one village panchayat as per the criteria for implementation in the financial year 1999-2000 and that the basic minimum services namely Drinking water, Primary Education, Public Health, Nutrition, Shelter, Rural Roads and Connectivity and Fair Price shops will be provided. This scheme should be implemented in full before the end of March of the financial year and that the Collectors should take all measures necessary for successful implementation of this scheme. All the works under this scheme should be implemented expeditiously and that where the schemes are implemented sign boards kept in these places, besides mentioning Anna Marumalarchi Thittam, the scheme under which the particular work is executed namely Indira Awaas yojana, Jawahar Velai Vaippu Thittam etc. should also been written on these boards.

3. Having taken into consideration of the existing guidelines and revision needed thereon a fresh guideline for the year 1999-2000 is issued. Government direct that the appended (Annexure/ Enclosures) guidelines shall be followed for implementing Anna Marumalarchi Thittam in the State.

4. The Government also direct that convergence of State and Centrally sponsored schemes as applicable in each Anna Marumalarchi Thittam village panchayats should be adopted following the norms and parameters prescribed for the respective schemes and programmes. Tamil Nadu Water Supply and Drainage Board is entrusted with all the Water supply schemes other than hand pumps, for which Tamil Nadu Water Supply and Drainage Board will avail the funds under Accelerated Rural Water Supply Schemes/ Minimum Needs Programme / Basic Minimum Services.

5. Government also set apart special fund of Rs.75 crores for the implementation of Anna Marumalarchi Thittam and order to release the same on the basis of per capita allotment to be made separately. However, Government authorise Director of Rural Development to draw and disburse to Collectors totally Rs.10.55 crores at the rate of Rs.5 Lakhs to each of 211 village panchayats selected under Anna Marumalarchi Thittam as the first instalment. Balance amount of Rs.64.45 crores will be released in 3 more instalments in july, September and November 1999. For the said expenditure Head of Account will be "2515.00. other Rural Development Programmes

800.Other expenditure Schemes in the Ninth Five Year Plan-II State Plan-JX- Implementation of Anna Marumalarchi Thittam-09. Grants-in-aid. (DPC No.2515 00 800 JX 0905)".

6. The Government have issued the new guidelines for implementation of Anna Marumalarchi Thittam for the year 1999-2000. The appended guidelines supercedes all earlier guidelines and the new guidelines issued for the year 1999-2000 as appended to this order will come into force with effect from the date of this order.

7. This order issues with the concurrence of Finance Department vide its U.O..No.1559/ FS/P/99, dated 10.5.1999.

GUIDELINES FOR THE IMPLEMENTATION OF ANNA MARUMALARCHI THITTAM DURING 1999-2000.

Anna Marumalarchi Thittam aims at convergence of all basic minimum services and infrastructures in the selected Village Panchayats to fulfil the necessary basic needs and make the village a model, self reliant, self sustained and regular village planning, public grievance redressal, participatory approach in local self Government and rural development. Thus the village benefited under Anna Marumalarchi Thittam will have many basic facilities as in the urban areas.

1. SELECTION OF VILLAGES:

Member of the Legislative Assembly will select a village panchayat on the basis of the criteria indicated herein and inform the same to District Collector. All Collectors should check the selected village panchayats as per the criteria and if found eligible, can accord approval, intimate the same to the President, village Panchayat and Member of the Legislative Assembly. This process of selection of Village panchayats in consultation with the Members of the Legislative Assembly Constituencies for 1999-2000 should be finalized before **31.5.99**. The list should be communicated to Director of Rural Development by the Collectors on or before **15.6.99**.

Each member of the Legislative Assembly Constituency shall select a village panchayat in his constituency on any one or more of the following criteria and shall mention the criterion clearly on the basis of which the selection was made and the name of the village panchayat in writing to the District Collector. The Selection shall be made only once and will be final.

Criteria

- a) Village panchayat with the highest population.
- b) Village Panchayat with the highest population of people belonging to SC/ST or BC and MBC.
- c) Backwardness of the village panchayat in terms of available infrastructure facilities. (Roads, Schools, Health Centres etc.,)
- d) Lower literacy rate of the village panchayat compared to the State average.
- e) Remote Village Panchayat from the District head quarter in terms of distance and located in inaccessible areas.

2. PREPARATION OF PANCHAYAT VILLAGE DEVELOPMENT PLAN:

- (i) As a first step, after selecting the village panchayat, local revenue and development administration will be toned up by the visit of officers team comprising Tashildar, BDO, and officials of Social Welfare, Adi Dravida Welfare, Health, Agriculture, Animal Husbandry and other development Departments as a Team similar to mass contact programme. As a part of confidence building exercise they will study local problems, identify the infrastructural gaps and community needs to ensure full coverage of welfare and development schemes.
- (ii) Second step relates to the conduct of a Rapid Appraisal of Resource Endowments (RARE). The Appraisal comprises of a rapid survey to assess the available resources and the gap in the seven basic services namely, (i) drinking water (ii) primary education (iii) Health (iv) Nutrition (v) housing (vi) roads and streets and (vii) public distribution plan for a village system etc. The connected format is at Enclosure I. The development plan for a village should be prepared on the basis of (a) the survey report brought our under the RARE and (b) the petitions received during Mass contact / grievance day. The village development, plan can be prepared with the help of the Officers of Rural Development, Revenue and other Departments. Makkal Nala Paniyalargal of the concerned Panchayats can also be engaged along with other staff. Enclosure II gives the list of officers

responsible for preparation of sectoral development plans. BDO (Panchayats) will be reponsible to intergrate the sectoral plans and prepare a draft Village Development Plan.

- (iii) The third step will be regular mass conduct Programme and launching of the Anna Marumalarchi Thittam. After toning up local administrative setup, Collector/ District Revenue Officer/ Project Officer. DRDA will conduct a regular Mass Contact Programme in the village. All district level officers will attend the meeting which will preferably be convened in the morning. The District Collector will appraise the public about the Anna Marumalarchi Thittam and also about various Government schemes to be implemented in the village. Petitions will be received from the public. These petitions will be scrutinized for redressal. Simultaneously, health camps, eye camps, exhibition displaying various Government Department activities veterinary camps etc., can be organized on mass conduct day. Hon'ble Minister in charge of the District or any other Hon'ble Minister may also be invited to participate and launch the Anna Marumalarchi Thittam in the panchayat. The village plan will have details in two Parts in the following way:-
- **Part-I** General Information of the village including a report on natural resources appraisal (land, soil, water, Tanks, irrigation sources, roads, schools, hospitals, etc.)

Part II - A Schemes involving financial commitments:-

- Schemes for community needs: Details of sector wise, department wise works like roads, school building, water tank, buildings for Noon Meal Centre, Community Centres, PDS Livestock Centres etc. with estimates and source of funding for the execution should be identified.
- (ii) Schemes for individual needs like issue of house site patta, construction of group house housing loan, Provision hut lights benefits under Swarnajayanthi Gram Swarozgar Yojana (SGSY), Mahalir Thittam etc.

B. Convergence and dovetailing of Schemes:

Ongoing schemes already approved in the current year can be converged for implementation in the panchayat selected under Anna Maumalarchi Thittam. These schemes can be treated as dovetailed ones.

C. Programmes not involving financial commitment:

These need mere integration, coordination, facilitation and liasoning- for example filling up of the Doctor's post in Primary Health Center, teacher's post lying vacant, or provision of a bus stop etc.

D. Campaigns for Quality of life improvement:

While drawing up village development plan for the panchayats special campaign programme for a year should also be planned to improve quality of life of the people in the panchayat. Education/literacy for all, health care cover for all, housing for all families, environmental sanitation, social forestry coverage are some of the campaigns to be undertaken in a mission mode. Every month even every week some of the programmes should be conducted. This would involve drawing up a yearly calender of campaign. Hence such campaigns and camps can be organized by linking Arivoli to eradicate illiteracy, and to achieve universal education or using blindness control movement, leprosy eradication programme, child care programme, to campaign for health and nutrition, Prohibition propaganda or small savings campaign, or similar programmes can be brought under this. Hence a calendar of campaigns can be prepared in the plan for implementation over a period of one year. An illustrative list is given in the Enclosure III. This is not an exhaustive list but only illustrative one.

3.APPROVAL OF THE VILLAGE PLAN BY THE GRAM SABHA:

The draft village plan so prepared (as per para 2 above) is only tentative one. This should

be placed in the village panchayat and after getting the views should be brought before Gram Sabha by convening a special meeting and works should be prioritized, all proposal including calender of campaigns finalized. As far as possible, schemes identified should be dovetailed with the ongoing schemes. Rural Water supply scheme for drinking water facilities in these villages will be funded through appropriate programmes by Tamil Nadu Water Supply and Drainage Board. Only in the case of schemes, which cannot be dovetailed, provision should be made from the special grant under Anna Marumalarchi Thittam allocated to the district. The RARE survey and mass conduct programmes should be completed before 30.6.99 and plan should be finalized with sanctioned grants and dovetailed funds. The copy of the plan should be sent to District Collector for according administrative sanction, before 15.7.99.

4. SCHEMES TO BE INCORPORATED IN THE PLAN:

4.1 Priority Schemes:

Priority should be given in the fulfillment of the following seven basic amentities as detailed below:

- 1. Potable Drinking water: Habitations with more than 150 population should be provided with piped water supply from Power Pump Scheme or Combined Water Supply Scheme. In smaller habitations for every 50 population one hand pump with an assured supply of 40 lpcd will be ensured. Power pump schemes will be executed by TWAD. Other schemes like hand pump, extension of pipeline etc., will be executed by village panchayats.
- 2. Education: Adequate number of primary school as per present norms of Government and adequate building space, drinking water, toilet for the existing primary Schools/ Middle Schools / High School/ Higher Secondary Schools, Computer education facilities as per the latest guidelines of Government in School Education Department shall be fully implemented. School sanitation including toilets, sanitation awareness should also be organized. Universal education for all and minimum education upto VIII Standard for girl children, adult non-formal education for illiterate, achieving the goal of cent percent literacy etc should be main goal. Arivoli volunteers can be actively involved in cent percent enrollment and eradication of illiteracy. Special efforts will be made for the enrollment of the school dropouts.
- **3. Health Cover:** Access to minimum health services to the villagers through Health Sub-Centres and Primary Health Centres should be ensured. Improvement of available facilities in these centers can be executed. Health check up and curative health care for all students in the schools in the panchayat shall be undertaken as per Valvoli Thittam. Preventive and promotive health education on immunization, pre-natal, post-natal childcare, family welfare activities etc., through organizing campaigns should be undertaken in a sustainable manner. Efforts should be focused on health education apart from convergence of all necessary health services.
- 4. Nutrition: Providing building and other infrastructures like drinking water for ICDS / Noon-meal centers, kitchen sheds to the school noon-meal centers, etc. establishment of Balwadies / Noon-meal centers on need basis as per existing norms. Providing nutritious food through Balwadies upto 3 years and at Noon-meal centers after 3 years. Special campaign shall be organized for propagating the nutrition and diets particularly targeted to educate mother groups on the value of locally available nutritious food.
- 5. Housing and Street Lights: Issue of house site pattas and construction of houses to the houseless families, rural housing loan to the eligible beneficiaries not having own house shall be arranged. Provision of household having toilets and group toilets should also be organized.

All huts will be provided with hut lights. Street lights should be provided to all habitations as per existing norms.

- 6. Upgradation of Roads and Lanes: Black topping of roads which mainly connect villages with more than 1000 population. (Only important roads should be taken up). Paving of the village roads, small lanes and by lanes in the village can also be taken up. Upgrading of all other link roads and streets with minimum standard of metalling or coverage with cut stones, bricks, cement slabs depending on local needs and availability of resources. Approach roads to the bus stand from the main road should be cemented / black topped.
- 7. Fair Price Shops: Providing the access to Fair Price Shops within 2 kms distance, either by creation of new shops or through sub-centers. Construction of pucca building for main Fair Price Shop located in the village. Formation of village vigilance committee to ensure proper functioning of PDS shops, issue of family cards to all eligible families and elimination of all bogus cards should be ensured.

4.2 Schemes for individual Beneficiaries:

Under the Individual benefit schemes all eligible beneficiaries for house site pattas, monthly old age pension schemes, welfare schemes should be accommodated. As far as possible all eligible beneficiaries under Swanajayanthi Gram Swarozgar Yojana (SGSY) should be covered. Self help groups should be formed in the village Panchayat. Efforts should be made to link villages with telephone, establishment of post office, and to provide library and television for all habitations in the panchayat.

4.3 Other necessary Schemes/ Services:

Abolition of child labour, improving sanitation in the village through CRSP enforcement of prohibition, opening of small savings account by all household, etc. should be fulfilled as far as possible. Similarly other asset creation works can be taken up.

5. FUNDING:

After exhausting funds converged under dovetailing with State plans and Centrally Sponsored Schemes like EAS/JRY/MLACD/MPLAD/ DDP Tenth Finance Commission Grant etc, gap alone can be filled up from special grant sanctioned by the Government under Anna Marumalarchi Thittam. Government is sanctioning Rs.75 crores as a special grant to be apportioned among 211 village panchayats selected during 1999-2000 for the implementation of Anna Marumalarchi Thittam. This fund will be distributed to the village panchayats by the District Collectors on the need basis, however, each district will be allotted funds only on percapita basis. This means on the basis of the 1991 Census Population for each Anna Marumalarchi Village Panchayat. Director of Rural Development will draw and disburse the amount in four instalments. (First installment being Rs.5 Lakhs to each village panchayat, balance funds will be released in 3 equal installments.)

However funds release will not be a constraint in the implementation of Anna Marumalarchi Thittam. If advance release is needed for any district, the same will be done. Expenses on the survey, projectisation, documentation of village development plan, and IEC activities will be met from the 2% of the total fund released to a district. Balance 98% and saving from the above 2% will be utilized for the works.

6. MODE OF EXECUTION:

All the works under Anna Marumalarchi Thittam other than dovetailed schemes shall be executed through open tender system. In the case of dovetailed schemes, the respective scheme guidelines will be applicable while executing the works. Collector will have the discretion of deciding the executing agency. Even line departments may be entrusted with works.

District Level Committee: For the purpose of scrutinizing the plan, monitoring and reviewing the progress, a District level Committee comprising of the following members will be formed. The Committee will meet once a month, take stock of the progress and problems provide guidance to the implementing agencies and remain in overall charge of the Programme implementation in the district.

The District committee will comprise of the following:

- 1. District Collector Chairman
- 2. Project Officer, DRDA- Member Secretary
- 3. All Members of Legislative Assembly
- 4. Concerned Panchayat Presidents
- 5. Concerned Panchayat Union- Chairman
- 6. District Head of Development Departments
- 7. A NGO to be coopted by the Collector.

7. INFORMATION, EDUCATION AND COMMUNICATION (IEC)

Collectors shall organize IEC activities through print and electronic media, phamlets, bit notices etc. highlighting the principles of Anna Marumalarchi Thittam and its success stories. Villagers should have the opportunity to see thematic development/welfare oriented Video films suitable to them. Director of Rural Development will prepare draft document of State Development Report on the Anna Marumalarchi Thittam and submit to Government by June end of next year for approval and publication.

8. DOCUMENTATION:

The District Collector should document various process of this scheme implementation starting from MCP, RARE village Development Plan up to completion of the Thittam as a record for evaluating the scheme impact on the village community. Further, documenting deliberations, keeping photographs and videos, etc. will be very useful for comparision. He can also document RARE survey as base line study and compare position in the post Anna Marumalarchi Thittam period to make development impact analysis. Purpose is to bring out a book at the State level on the success and impact of this programme as indicated in Para 7 above.
