Formation of 10,000 Youth SHGs during 2006-07

ORDER

The Hon'ble Minister (Rural Development & Local Administration) has announced in the Legislative Assembly that 10,000 Youth Self Help Groups will be formed during 2006-07 with an allotment or Rs.10.00 Crores. Accordingly, the Managing Director, Tamil Nadu Corporation for Development of Women has sent a proposal for the formation of 10,000 Youth Self Help Groups in 2006-07.

2. Women Self Help Groups were formed originally for social empowerment. Youth Self Help Groups will have economic empowerment as the primary focus, Therefore, the focus will be on skill training for increasing their employability and promotion of economic activities. In addition, Youth Self Help Groups will be trained in SHG concept, savings, etc like Women Self Help Groups.

The Salient features of Youth SHGs will be:

- Groups will be formed based on economic activities.
- Skill training will be imported to increase employability and to promote self-employment.
- Exposure visits will be arranged to expose youth to various opportunities available in today's society.

3. Group Formation

The Managing Director, Tamil Nadu Corporation for Development of Women has proposed to form 10,000 Youth Self Help Groups in 2006-07. The Self Help Groups will be formed with unemployed youth in the age group of 18 to 35 years. Each group will comprise 10 to 20 members drawn from the below poverty line population. These Self Help Groups will be formed in all the 30 districts in both urban and rural areas. The Non Governmental Organizations affiliated with Tamil Nadu Corporation for Development of Women will be engaged for forming these groups and Group formation cost of Rs. 350/- per group will be paid to Non Governmental Organizations.

4. Monitoring Cost

To closely monitor and handhold Youth Self Help Groups Non Governmental Organizations forming the Self Help Groups will be provided monitoring cost on the same pattern like women Self Help Groups.

The average rate of monitoring cost works out to Rs.27.50 per Group per month for eight months (for the period from August 2006 to March 2007).

5. Self Help Groups member training

This training will be imparted to all the members of the Youth Self Help Groups. The basic concepts about functioning of Self Help Groups will be taught during this training. Training will be in 4 modules in 4 days.

6. Animator and Representative Training

The Animator and any one Representative of each Self Help Groups will be imparted this training which focuses on leadership, team building and maintenance of accounts. It will be in 3modules spread over 6 days.

7. Skill Training

Providing marketable skills to unemployed youth is very essential to improve their employability. This program will lay stress on imparting skill training through established industries and reputed institutions. The objective will be to either get wage employment based on the skills acquired or encourage self – employment ventures. This skill training will be provided to unemployed youth who are members of SHGs as well as others. Operational guidelines regarding skill training will be issued by the Board of Tamil Nadu Corporation for Development of Women.

8. Provision of revolving Fund

6 months after formation, the Youth Self Help Groups will be graded and efforts will be taken to provide credit linkage. To facilitate credit linkages, Rs. 10000/- will be provided as grant towards revolving fund.

Break-up details of Expenditure:

The Scheme cost works out to Rs. 10.00 Crores for the current financial year and has been provided in revised budget estimate 2006-07. Therefore he has requested to approve the proposal and release a sum of Rs. 10.00 crores (Rupees Ten Crores only) for the year 2006-07.

9. The Government after careful examination has accepted the proposal of Managing Director, Tamil Nadu Corporation for Development of Women and issue the following orders:-

- 1. 10,000 Youth Self Help Groups shall be formed in all the 30 districts in both urban and rural areas with unemployed youth in the age group of 18-35 years. Comprising of 10 to 20 members for each group from the below poverty line population by engaging the Non Governmental Organizations affiliated with Tamil Nadu Corporation for Development of Women.
- 2. Group formation cost of Rs. 350/- per group shall be paid to the Non Governmental Organizations.
- 3. The Non Governmental Organizations forming the Self Help Groups shall be provided monitoring cost on the same pattern like women Self Help Groups as detailed below:-

- 4. All the members of the Youth Self Help Groups shall be imparted training on the basic concepts about functioning of Self Help Groups in 4 modules in 4 days.
- 5. The Animator and any one Representative of each Self Help Groups shall be imparted training focusing on leadership, team building and maintenance of accounts in 3 modules in 6 days.
- 6. The skill trainings shall be provided to unemployed youth, who are members of Self Help Groups through established industries and reputed institutions with the objective of getting wage employment or to encourage self-employment.
- 7. The operational guidelines on skill training shall be issued by the Tamil Nadu Corporation for Development of Women with the approval of the Board.
- 8. The Youth Self Help Groups shall be graded as per the procedure followed in respect of women Self Help Groups.
- 9. The Youth Self Help Groups shall be granted revolving fund of Rs.10,000/- to facilitate credit linkage.
- 10. The Government approves the following activities in relation to Youth Self Help Groups and expenditure during 2006-07.

11. The expenditure sanctioned in Para 10 above shall be debited to the following heads of account.
