ORDER

In G.O.Ms.No.56 Social Welfare and Nutritious Meal Programme Department, Dated 26.05.2006, the Government have permitted the formation of a District Project Officer (Mahalir Thittam) for the newly created Krishnagiri District and sanctioned a sum of Rs. 38.12 Lakhs with a direction to the Managing Director, Tamil Nadu Corporation for Development of Women Limited, that necessary explanatory notes be sent to Government to include the expenditure in the supplementary Estimates for 2006 – 2007 at an appropriate stage as this item constituted an item of new instrument of service.

2. Meanwhile, the Tamil Nadu Corporation for Development of Women Limited has been transferred to Rural Development and Panchayat Raj Department vide G.O.Ms.No.81 Rural Development and Panchayat Raj Department, Dated 20.7.2006.

3. The Managing Director, Tamil Nadu Corporation for Development of Women Limited has now informed that necessary funds have been provided as grants in Aid – in the Revised Budget Estimate 2006-2007 under Demand No.42, Rural Development and Panchayat Raj Department. He has therefore requested to issue amendments to the G.o.Ms.No.56, Social Welfare and Nutritious Meal Programme Department, Dated 26.05.2006.

4. The Government after careful examination issue amendments for the existing paragraphs 4 and 6 of the G.O. read above, the following new paragraph shall be substituted.

Paragraph-4:

The expenditure sanctioned above shall be debited to "2235 – Social Security and Welfare – 02, Social Welfare – 103, Women Welfare – Schemes in the Tenth Five Year Plan-II – LC – Tamil Nadu Women's Development Project (Mahalir Thittam) 09 Grants – in –aid 01, Grants for current expenditure (DP Code No.2235 02 103 LC 0919)" and the amount shall not be paid in cash but credited to the following head of account.

K Deposits and Advance (B) Deposits not bearing interests – 8443-00 Civil Deposits – 800 – Other Deposits – BP. Deposits of Government Companies Corporations etc. 28. Deposits of Tamil Nadu Corporation for Development of Women Limited – DPC 8443 – 00 -800 BP 0001 (Receipts)" by means of a cheque in favour of "P.D. account No.6184513080 of Tamil Nadu Corporation for Development of Women Limited.

Paragraph-6:

The Director of Rural Development and Panchayat Raj, Chennai is authorized to draw and disburse the amount to Tamil Nadu Corporation for Development of Woman Limited, Chennai – 32 as indicated above.
