ORDER

The Director of Town Panchayats has requested the Government to sanction a sum of Rs.16.00 lakhs for the construction of Pay and Use Toilets in Town Panchayats under Part II Schemes for the year 1994-95. He has also furnished details of Districts/Town Panchayats which require financial assistance for construction of Pay and use Toilets with the quantum of amount required for each Town Panchayat as detailed in the Annexure to this order.

2. The Government after careful consideration have decided to accept the proposal of the Director of Town Panchayats and they accordingly sanction a sum of Rs.16.00 lakhs (Rupees sixteen lakhs only) Rupees 8.00 lakhs as grants and Rs.8.00 lakhs as loan to the Director of Town Panchayats for disbursing the same to the Rural Town Panchayats as mentioned in the Annexure to this order for the construction of 10 (Ten) Pay and Use Toilets (8 without bathroom and 2 with bathroom). The amount sanctioned should be utilised for the purpose for which it is sanctioned. The Director of Town Panchayats is requested to execute the work and send a completion report to the Government within 3 months.

3. The grants portion of expenditure shall be detailed to the following head of account:
