ORDER

In G.O. Ms.No.136, RD., dated 24.7.95, Government sanctioned Rs.18 lakhs for construction of four residential quarters one each at in coastal blocks of Parangipettai in South Arcot District, Kadaladi in Ramanathapuram District, Valliyur Tirunelveli District, Manamelkudi in Pudukottai District at the rate of Rs.4.50 lakhs (Rs. Four lakhs and fifty thousand only) each under Part II Schemes 1995-96 out of an ultimate cost of Rs.36 lakhs.

2. The D.R.D. has stated now, that, out of the four Panchayat Union, the B.D.O's residential quarter at Valliyur Panchayat Union in Tirunelveli District has been completed. He has requested Rs.19.50 lakhs as revised administrative sanction for the remaining residential quarters of the B.D.Os of the three Panchayat Unions as follows:

3. After careful consideration, the Government sanction an additional amount of Rs.6.04 lakhs and also accord revised administrative sanction for Rs.19.54 lakhs for the amount sanctioned in the G.O. first read above for the construction of three B.D.Os. residential quarters at Manamelkudi in Pudukottai District, Kadaladi in Ramanathapuram District and Parangipettai in South Arcot District as mentioned in para 2 above.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account.

5. Necessary Provision will be provided in the RE/FMA 1999-2000 and pending such provision to the D.R.D. Chennai is authorised to draw and disburse the amount to the Collectors concerned for completion of the above construction work. The D.R.D. Chennai is requested to include this amount while sending proposals for RE/FMA 1999-2000 without fail to Government in Fin(PWD)Department.

6. A completion report of the building works and an utilisation certificate of this amount should be submitted to the Government within the prescribed time.
