## **ORDER**

In the G.O. first read above, administrative sanction was accorded to the State Action Plan on Swayamsiddha Scheme for 44 Blocks in 5 Districts at a total outlay of Rs.716.80 lakhs for the period from 2001 to 2006. A sum of Rs.17.02 lakhs has been sanctioned in the Government order second read above as second instalment for 2005-2006. The Government of India in their letters third read above have released a sum of Rs.1,50,01,000 (Rupees one crore fifty lakhs and one thousand only) as Grants – in – Aid for under Swayamsiddha Scheme for the year 2006-2007 to the Government of Tamil Nadu.

- 2. The Managing Director, Tamil Nadu Corporation for Development of Women Limited has requested the Government to release a sum of Rs. Rs.1,50,01,000 (Rupees one crore fifty lakhs and one thousand only) to Tamil Nadu Corporation for Development of Women Ltd. for the implementation of the Swayamsiddha scheme during the year 2006-2007 and also requested to authorise the Director of Rural Development and Panchayat Raj to draw disburse the above amount.
- 3. The Government after careful examination accord sanction and release a sum of Rs.1,50,01,000 (Rupees one crore fifty lakhs and one thousand only) for the implementation of Swayamsiddha Scheme during the year 2006-2007 to the Managing Director , Tamil Nadu Corporation for Development of Women Limited, Chennai-32.
- 4. The expenditure sanctioned in para 3 above shall be debited to the following head of account :
