ORDER

Entrepreneurship Development Training Programme (EDP), was introduced during the year 1998-1999 with the objective of exposing Self Help Groups women to various business opportunities and to motivate them to start economic activities. This Programme is implemented by Tamil Nadu Corporation for Development of Women Limited in coordination with other line departments like Rural Development, Industries and Commerce and Tamil Nadu Adi Dravida Housing and Development Corporation Limited.

Under this scheme, training is imparted to Self Help Groups women from credit rated groups in entrepreneurship for seven days. The training is imparted through Entrepreneurship Development Programme training institutions, women study centers, Colleges, Community Polytechnics and banks.

Till 31.03.2006, Tamil Nadu Corporation for Development of women Limited has given Entrepreneurship Development Programme Training to 1,14,747 Self Help Groups Women.

2. The Managing Director, Tamil Nadu Corporation for Development of Women Limited has proposed to provide the Entrepreneurship Development Programme Training to 22,000 Women from the credit rated Self Help Groups at a total cost of Rs. 88.00 lakhs as detailed below during 2006-2007.

3. The Managing Director, Tamil Nadu Corporation for Development of women limited has also requested the government to sanction Rs. 88.00 lakhs (Rupees Eighty Eight lakhs only) for the training Programme.

4. The Government have carefully examined the proposal of the Managing Director, Tamil Nadu Corporation for Development of Women Ltd., and accord sanction to impart Entrepreneurship Development Programme Training for 22,000 women from credit rated Self Help Groups for the year 2006-2007. The Government also sanction and release a sum of Rs. 88.00 lakhs (Rupees Eighty eight lakhs only) for the training Programme. The Tamil Nadu Corporation for Development of women limited shall follow the due tender procedure, as per the orders already issued.

5. The expenditure sanctioned in para 4 above, shall be debited to the following head of account.

"2235 Social Security and Welfare – 02 Social Welfare 103 Women's Welfare
– Schemes in the Tenth Five year plan II State plan – LK Entrepreneur
Development Training Programme for women – 09 Grants –in-Aid 03. Grants
for Specific Schemes (DPC 2235-02-103-LK 0931)

6. The expenditure sanctioned in Para 4 above shall not be paid in cash but paid by means of a cheque in favour of PD of Account no. 6184513080 of Tamil Nadu Corporation for Development of Women Limited.

7. The expenditure sanctioned in Para 4 above shall constitute an item of 'New instrument of Service' and approval of the legislature will be obtained in due course pending approval of the legislature the expenditure will met by an advance from the contingency fund. Orders regarding this will be issued by the Government in Finances (BG.I) Department separately. The Director of Rural Development and Panchayat Raj Chennai is requested to apply to the Government in Finance (BG-I) Department in the prescribed proforma along with this order for the sanction of all advance from the contingency fund. The Director of Rural Development and Panchayat Raj requested to include this expenditure while sending proposal for the Supplementary Estimate without fail.

8. The Managing Director, Tamil Nadu Corporation for Development of Women Limited shall credit the amount in the following head of Account.

"K Deposits and Advance (B) Deposits not bearing interest- 8443-00 Civil Deposits 800 – Other Deposits – BP Deposits of Government companies corporations etc., 28 Deposits of Tamil Nadu Corporation for Development of Women Limited (DPC 8443-00 800 – BP – 0001 (Receipts))."

9. The Director of Rural Development and Panchayat Raj, Chennai is authorized to draw the amount sanctioned in Para 4 above and disburse the amount as indicated at Para 5 above.

10. The Managing Director, Tamil Nadu Corporation for Development of women limited is directed to send the Utilization certificate and to the Accountant General, Government, and Director of Rural Development and Panchayat Raj along with the statement of expenditure. He is also instructed to remit the balance-unspent amount. If any into Government Account after completion of the Training.
