## 9.2 2004-05 - Release of Rs.3 crores for Socio-Economic Development activities in Naxalite affected Villages in Krishnagiri District

## ORDER

During the exclusive Police Officers Conference held on 10.08.2004, the Hon'ble Chief Minister has announced among others that a separate allocation of Rs.3.00 crores will be made for Krishnagiri District in 2004-05 for taking up of upgradation of road works in Thally and other areas. Accordingly, the Collector, Krishnagiri has sent detailed proposals for taking up certain Socio Economic Development Activities and sought for allotment of Rs.3.00 crores for 2004-05.

2. The activities to be taken up under the scheme are as follows:-

## 9. SOCIO-ECONOMIC DEVELOPMENT

It has been further reported by the Collector, Krishnagiri, that nearly 60% of the funds requested are proposed to be spent in Thally area. The Collector has sought for the early sanction of the sum of Rs.3.00 crores so as to enable him to take up the socio economic development activities. The Director of Rural Development has also recommended the request of the Collector, Krishnagiri above.

3. After careful examination, the Government have decided to accept the request of Collector, Krishnagiri District as recommended by the Director of Rural Development and sanction a sum of Rs.3.00 crores as announced by Hon'ble Chief Minister during the exclusive Police Officers' Conference held on 11.08.2004. The Government also considered that for rural roads, a sum of Rs.1.50 crores can be earmarked from this year's provision of Rs.175.00 crores and from the Minimum Needs programme, Rs.1.00 crore can be provided exclusively for the District and the backward areas in particular. These two provisions will be over and above the normal provision given to Krishnagiri District. A sum of Rs.50.00 lakhs can be provided for other development related works, for which necessary provision can be made in RE / FMA 2004-2005. Accordingly sanction is accorded by the Government,

- 1. for an earmark of Rs.1.5 crores to Krishnagiri District out of the Budget provision of Rs.175.00 crores for Rural Roads in BE 2004-2005;
- a sum of Rs.1.00 crore be provided exclusively to Krishnagiri District from the BE 2004-2005 out of the provision of Rs.274.00 crores made for Minimum Needs Programme; and
- a sum of Rs.50.00 lakhs be provided for other development activities in RE / FMA 2004-05;
- 4. The expenditure sanctioned in Para 3 above shall be debited to the following head account ;-

5(iii). The re-appropriation of funds ordered in Para 3(3) above shall constitute an item of a "New Service". Approval of Legislature will be obtained in due course by specific inclusion in the supplementary estimates. Pending inclusion in the Supplementary Estimates, the Director of Rural Development is authorized to incur the expenditure by re-appropriation and to send necessary notes for supplementary estimates to Government in Finance (Rural Development) Department at appropriate stage.

6. The Director of Rural Development is authorized to draw and incur the expenditure sanctioned in Para 3(1) and 3(2) above pending re-appropriation and provision of funds in RE / FMA 2004-05. The Director of Rural Development is also directed to send necessary proposal to Fin (RD / MA & WS) Departments for re-appropriating the funds in RE / FMA 2004-05.

7. The Government also approve the activities drawn by the Collector, Krishnagiri for being implemented under the scheme through the District Rural Development Agency, Krishnagiri.

8. The amount sanctioned in Para 3 above shall be utilized for the specific activities drawn and as approved by Government vide Para 7 above. The Collector, Krishnagiri District shall furnish the utilisation certificate in the prescribed format periodically to the Government in Rural Development Department; PD&SI Department; Finance Department and the Director of Rural Development, Chennai.

9. The Director of Rural Development shall monitor the progress of implementation of the scheme and ensure maintaining of the registers on creation of assets etc., as indicated in TNFC Vol.I.
