ORDER

In the Government order first read above the Government have issued orders for detailed procedure for the implementation of Anaithu Grama Anna Marunalarchi Thittam. The Director of Rural Development & Panchayat Raj in his D. O. letter second read above has requested orders of the Government on the following points:

- (i) Constitution of a committee for selection and finalisation of the location of works within the Anaithu Grama Anna Marumalarchi Thittam Village.
- (ii) Approval of works by the Grama Sabha
- (iii) Administrative Sanction
- (iv) Mode of Exectution
- (v) Constitution of District Level Committee
- (vi) Increase in the limits of expenditure for the Library and the Rural sports centre sub-components
- 2. The Government carefully examined the proposal of the Director of Rural Development & Panchayat Raj and issue the followig orders.
 - i. Committee for selection and finalisation of the location of works within the Anaithu Grama Anna Marumalarchi Thittam Village: A committee consisting of the Following members shall be constituted for each of the AGAMT Village which will be given the responsibility for the selection of the works and finalisation of the exact location of the works.
 - (a) Block Development Officer (Village Panchayat)
 - (b) Assistant Engineer/ Union Engineer of the concerned block
 - (c) Concerned Village Panchayat president

This committee should inspect all the sites before finalising the works and the location Random checks should also be made through the Zonal officer in the cadre of Assistant Director.

- ii Approval of works by the Grama Saba: Approval of the Grama Sabha shall be obtained for all works selected.
- iii. Administrative Sanction: The District Collectors are empowered to accord administrative sanction for the works taken up under this scheme.
- iv. Mode of Execution: The Block Development officer (Village Panchayat) is designated as the tender inviting authority for the purpose of this scheme. He is empowered to accept tenders upto a value of Rs. 5 lakhs without any tender excess. The collector is empowered to accept tenders of a value of more than Rs.5 lakhs and for tenders with a tender excess upto a maxium of 5% over and above the estimates.

4. AGAMT

v. District Level Committee : A District Level Committee comprising the following members shall be constituted for the purpose of dovetailing of schemes and activities of different district level departments in AGAMT villages and for montoring the progress. The Committee will meet one in a month take stock of the progress and problems provide guidance to the implementing agencies and remain in overall charge of the programme implementation in the district. The Composition of the District committee will be as given below :

Vi. Increase in the limits of expenditure for the Library and the Rural sports Centre subcomponent: As per the G.O (Ms) No.115, Rural Development & Panchayat Raj Department dated, 11.9.2006, Rs.1.00 lakh and Rs,50,000/- have been fixed as the upper limits for the Library and Community Rural sports centre sub components respectively. Taking into consideration the feed back of the Collectors that the allocations in this regard will be insufficient the Government Order the enhancement of the upper limits to Rs.2.00 lakhs and Rs.1.00 lakhs for the library and community rural sports centre sub components respectively.
