ORDER

In G.O.Ms.No.164, R.D., dt.28.8.95 Government sanctioned an amount of Rs.7.00 lakhs (Rupees seven lakhs only) for construction of Administrative Blocks and R.3.00 lakhs for construction of four class rooms at T.Kallupatti for the year 1995-96 under part II scheme, the ultimate cost of the scheme was Rs.20.00 lakhs (Rupees twenty lakhs only) of which Rs.14.00 lakhs (Rupees fourteen lakhs only) were meant for the construction of Administrative Buildings and the balance of Rs.6.00 lakhs (Rupees six lakhs only) for the construction of four class rooms at T.Kallupatti, Madurai District.

2. Now, Director of Rural Development, has stated that the construction work of the four class rooms at T.Kallupatti has come up to the roof level and the balance amount of Rs.3.00 lakhs (Rupees three lakhs only) is required for completion of the construction of class rooms for Rural Extension Training Centre in T.Kallupatti, and has, therefore, requested the Government to sanction the above amount.

3. After careful consideration the Government sanction the balance amount of Rs.3.00 lakhs (Rupees three lakhs only) towards the completion of the construction of four class rooms for Rural Extension Training Centre in T.Kallupatti.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account.

"4515.00 Capital outlay on Other Rural Development Programmes -102
Community Development - Schemes in the Ninth Five Year Plan - II. State
Plan JA Buildings - 16. Major Works (DP.Code No.4515 00 102 JA 1602)"

5. Necessary Provision will be provided in Final Modified Appropriation 1997-98, pending such provision. The Director of Rural Development is authorised to draw and disburse the amount to the Collector concerned of the above construction work. The Director of Rural Development, requested to include this amount while sending proposals for Final Appropriation 1997-98 without fail.

6. A completion report of the building works and Certificate of this amount should be submitted to the Government within the prescribed time.

7. This order issues with the concurrence of the Finance Department vide its U.O.87936/RD/97-1, dated 7.11.97.
